**PURPOSE STATEMENT – Community Correction Partnership**

The mission of the Community Corrections Partnership (CCP) is to discuss issues related to the implementation of various pieces of state legislation that focus on adult criminal offenders, including the realignment of many state public safety functions to local jurisdictions. The overall objective is to reduce the recidivism rate of adult offenders in the local criminal justice system.

Membership of the CCP is defined by the Community Corrections Performance Incentive Act of 2009 (SB 678) and includes the Chief Probation Officer (Chair)\*, Presiding Judge of the Superior Court\*, a County Supervisor or County Administrator, District Attorney\*, Public Defender\*, Sheriff\*, the head of the Department of Social Services\*, the head of the County Department of Mental Health, the head of the County Department of Employment, the head of the County Alcohol and Substance Abuse programs, the County Superintendent of Education, a local chief of police\*, a representative of a community-based organization with experience in successfully providing rehabilitative services to persons convicted of criminal offenses, and an individual who represents the interests of victims.

Through AB 109/AB117 the CCP is responsible for recommending a local plan to the county Board of Supervisors (BOS) for the implementation of the 2011 public safety realignment. This legislation also established an Executive Committee within the CCP. Each Executive Committee member is identified with an asterisk (\*) above. The Executive Committee is responsible for approving the local plan for recommendation to the BOS.

## **Call to Order**

The meeting was called to order at 3:10 p.m. Chief Hansen welcomed and requested introduction of members. Chief Hansen announced September is National Recovery Month.

## **Approval of Agenda**

Lesli Caldwell requested an additional item to be placed on the agenda -“Urgency Exception.” Chief Hansen motioned to have this item added to the agenda as Item 6a – Stanford Criminal Justice Center at Stanford Law School research study. Patrick Duterte made a motion to accept the addition. Don du Bain seconded the motion. No opposition. Motion carried (5-0). Judge Beeman and Sheriff Stanton were absent from the vote. Chief Hansen also noted that Item 7 did not require a vote from the Committee.

Don du Bain made a motion to approve the agenda. The motion was seconded by Patrick Duterte. No opposition. Motion carried (5-0).

## **Public Comment**

An opportunity was provided for members of the public to address the committee on matters not listed on the Agenda.

Pastor Anthony Summers of Michael’s Transportation - Admissions and Job Coordinator, gave a presentation on the training academy. *“Putting Solano County Back to Work.” (See handouts – Attention out-of-work Americans: Want to be a trucker?)*

**Data Report** (*See Handout - PowerPoint – Probation Department and Sheriff’s Office Data Presentation September 12, 2012*)

Donna Robinson presented statistical information pertaining to the Post-release Community Supervision (PRCS) population for the month of August 2012.

- 356 Clients under supervision
- 0 Grants expired; 0 Grants revoked; 7 Revoked since October 2011
- 4 Failed to report; 51 since October 2011
- 4 Transferred out of Solano County; 39 since October 2011
- 3 Transferred in; 20 since October 2011
- 4 Bench warrants ordered; 5 warrants cleared (August 2012)
- 12 Bench warrants for PRCS/FTA from CDCR (Outstanding since October 2011)
- Cities w/highest PRCS: Vallejo 40%; Fairfield 32%; Vacaville 16%; Suisun 6%; Dixon 6%; Rio Vista and Benicia 1%
- Risk Level of Re-offending: Very High 15 %; High 63 %; Medium 21%; Low 1%
- Ethnic Profile: African American 45%; Caucasian 37% Hispanic 13%; Other 5%

- Gender: 94 % male; 6 % female
- Age Profile: 8 % (18-25); 19% (26-30); 32% (31-40); 28 % (41-50); 11% (51-60); (60 +) 2%

Gary Elliott provided statistical information pertaining to the jail population as a result of Public Safety Realignment for the month of August 2012.

- Jail Population: 949
- Parolees (3056):177 in custody represents 18.6% of jail population
- 1170(h) (N3's): 161in custody represents 17.1 % of jail population
- PRCS: 34 in custody represents 3.5 of jail population
- Statistical information was presented on compliance checks for the month of August. Sheriff Enforcement Team (SET) Most Wanted 127 – 88 Apprehended

Deborah Johnson, North Bay District Administrator reported that parole violations will not be handled through CDCR Institutions as of July 1, 2013, which will probably increase the population in the County jail. Kevin Golson of CDCR explained that depending on the arrest and the category of the committing offense of the Parolee, several things may happen. If the offense is serious, the Parole Board determines the sanction. Non-serious offenses may be adjudicated at the Unit level through the Unit supervisor. Since the implementation of AB109, non-serious violations carry a maximum term of 6 months.

Chief Hansen and Kevin Golson will meet to discuss the Revocation process in Solano County to include developing a plan on how to address parole violations/revocations at the local level.

### **Data Subcommittee Report**

Gary Elliott reported the sub-committee's data collection efforts are fairly static. Probation is reporting specific information (data) to the Chief Probation Officers of California (CPOC) and the Sheriff's Office is reporting specific information (data) to the Board of State and Community Corrections (BSCC). CPOC published a report in July 2012 that summarized a lot of the Data Collection efforts, and they will be updating that report periodically. BSCC is working to publish a similar report, but their efforts have been delayed due to organizational restructuring. Carol Cain is still meeting with representatives from Probation, HSS, and the Sheriff's Office to review data collection as it relates to sharing information at the local level.

**Day Reporting Center Framework** - Chief Hansen distributed the Public Safety Realignment Day Reporting Center Implementation Plan Framework submitted by Corrections Consultant Thomas White. Attachments of the plan will be placed on the Probation Department's website under the Community Corrections Partnership.

The committee agreed to move forward with the framework of Tom White's report. Chief Hansen proposed moving the next CCP meeting to October 17, 2012 in order for Tom White to give an updated report to the committee.

Lesli Caldwell – (Added Item 6a) - The Stanford Law School is conducting research regarding the Realignment laws and the effect on County decision making. Stanford Law School has invited Solano County as one of the six counties to participate in the study. This would consist of interviewing the voting members of the CCP which will take approximately 45 minutes for each person. The results will be shared with the State Legislature, the Attorney General, and the

Governor's Office. Don du Bain made a motion for the Committee to participate in the study. Patrick Duterte seconded the motion. No opposition. Motion carried. (5-0).

### **Public Safety Realignment Implementation Plan for 2012**

The committee approved the County of Solano Public Safety Realignment Plan for 2012. The committee carried the 2011 plan forward and adopted the plan for 2012. Chief Hansen suggested the Committee look at the plan before the end of the calendar year. Patrick Duterte made the motion to approve the plan. Don du Bain seconded the motion. No opposition. Motion carried (5-0).
