

**THIRD AMENDMENT TO STANDARD CONTRACT  
BETWEEN COUNTY OF SOLANO and SOLANO COUNTY OFFICE OF EDUCATION**

This Third Amendment ("Third Amendment") is made on July 1, 2011, between the COUNTY OF SOLANO, a political subdivision of the State of California ("County") and the SOLANO COUNTY OFFICE OF EDUCATION, ("Contractor").

1. Recitals

A. The parties entered into a contract dated August 14, 2008 (the "Contract"), in which the Contractor agreed to provide educational services to County jail inmates.

B. The Contract was amended on April 28, 2009 to extend the Contract term and increase the maximum amount.

C. The Contract was amended on July 1, 2010 to extend the Contract term and increase the maximum amount.

D. The County now needs to amend the Contract term from July 1, 2011 through June 30, 2012 and include an additional \$82,598 in compensation for this extended term.

E. The parties agree to amend the Contract as set forth below.

2. Agreement

A. Term of Contract

Section 2 of the Standard Contract is amended as follows:

The term of this Contract is: August 14, 2008 through June 30, 2012.

B. Amount of Contract

Section 3 of the Standard Contract is deleted in its entirety and replaced with:

The maximum amount of this Contract is: \$330,410.

C. Budget

1. Section 1 of Exhibit B is amended as follows:

The total amount of this Contract shall not exceed \$330,410.

2. Exhibit B-3 of Exhibit B is deleted in its entirety and replaced with the program budget for the period of July 1, 2011 through June 30, 2012 as set forth in Exhibit B-4 below.

3. Section 2B of Exhibit B is amended as follows:

Any changes to Exhibit B-4 that increase or decrease staffing levels or budgeted expenses must be memorialized in writing and agreed to by both parties.

4. Exhibit B-4 is added as follows:

Except as set forth in this Third Amendment, all other terms and conditions specified in the Contract remain in full force and effect.


