

**FIRST AMENDMENT TO STANDARD CONTRACT
BETWEEN COUNTY OF SOLANO and THE WRIGHT INSTITUTE**

This First Amendment ("First Amendment") is made on July 1, 2011, between the COUNTY OF SOLANO, a political subdivision of the State of California ("County") and The Wright Institute, ("Contractor").

1. Recitals

A. The parties entered into a contract dated September 13, 2010 (the "Contract"), in which Contractor agreed to provide psychological services to inmates.

B. The County now needs to amend the Contract to extend the Contract's term from July 1, 2011 through June 30, 2012, include an additional \$42,700 in compensation for this extended term and replace reference to Dr. Castell with a generic position description.

2. Agreement

A. Term of Contract

Section 2 of the Standard Contract is amended as follows:

The term of the Contract is: July 1, 2010 through June 30, 2012.

B. Amount of Contract

Section 3 of the Standard Contract is deleted in its entirety and replaced with:

The maximum amount of this Contract is: \$85,400.

C. Scope of Work

1) Section 1.b of Exhibit A is deleted in its entirety and replaced with:

b. Individual supervision for these Students from an Outside Psychologist assigned by the Wright Institute. This Psychologist will be a Phd. level psychologist with at least 3 years clinical experience in a correctional facility setting.

2) In all Sections of Exhibit A replace Dr. Mike Castell and Dr. Castell with "Outside Psychologist".

D. Budget

1) In all Sections of Exhibit B replace Dr. Mike Castell and Dr. Castell with "Outside Psychologist."

2) Section 1 of Exhibit B is deleted in its entirety and replaced with the following:

The total amount of this Contract shall not exceed \$85,400.

3) Section 2 of Exhibit B is deleted in its entirety and replaced with the following:

2. BUDGET FOR JULY 1, 2011 THROUGH JUNE 30, 2012.

3. Effectiveness of Contract

Except as set forth in this First Amendment, all other terms and conditions specified in the Contract remain in full force and effect.


