Pursuant to the Request for Proposal (RFP) for Mental Health Services Act; Prevention and Early Intervention; Homeless/Mentally III Services, section 3.20, the County of Solano has amended this RFP to reflect:

1) Section 1.1 is hereby amended to reflect the language below:

The County of Solano, Health and Social Services, hereinafter referred to as the County, intends to secure a contract from qualified organizational applicants to administer and provide specific services to homeless mentally ill individuals within the an expanded Transition Age Youth (Ages 12-25) Homeless Mentally III component of Prevention and Early Intervention. This project is funded by the Mental Health Services Act and will be a three-year effort of the Department of Health & Social Services Mental Health Division, with funding up to \$500,000 for Year 1, \$500,000 for Year 2, and \$500,000 for Year 3.
