Call to Order

> Public Safety Local Plan Development

The draft plan was reviewed and edits/notes were made in the document by consultant Suzie Cohen. A motion was made by Judge Daniels to eliminate two paragraphs on page 8 of the document; second by Don Du Bain. Oscar Bobrow was present for Lesli Caldwell; discussion took place regarding whether or not he could vote as her proxy; decision was made not to allow it. Motion carried, 5-1, Isabelle Voit opposed.

The Committee requested information to support the amounts identified in the funding priorities.

Given the need to further revise the plan draft and receive additional information regarding funding priorities, a vote regarding the plan was not taken. Due to scheduling issues, it was decided to delay the date established to take the plan to the BOS (October 4, 2011) with a new date to be set at the next CCP meeting. Motion made by Isabelle Voit to go to the BOS ahead of the local plan to request the addition of 3 Deputy Probation Officer position; second by Don du Bain; motion carried 5-1, Judge Daniels opposed.

Those responsible for priority funding items agreed to provide more detailed information supporting the funding amounts. Information to be provided to Isabelle Voit by September 16, 2011, for compilation and distribution to the Committee prior to the next meeting (target of one week in advance).

Ruth Forney provided information about a Reentry Council meeting on September 15, 2011, which will include a presentation by Jeanne Woodford.
