Public Safety Local Plan Development

The revised draft plan was discussed and edits were made in the document by consultant Suzie Cohen. Judge Daniels expressed concerns about adopting a plan now with legal changes still occurring. Public Defender Caldwell stated disagreement with the decision made at the last meeting to delete language about the intent of the legislature with regard to rehabilitation. The committee confirmed the funding priorities identified at the last meeting, which will be listed in alphabetical order in the plan. A motion was made by Sheriff Stanton to adopt the plan as revised; second by Chief Word; motion amended to include Patrick Duterte's clarifications that the final plan will include an executive summary, flow chart and list of acronyms. Motion carried, 5-2, Judge Daniels and Public Defender Caldwell opposed.

Funding requests were discussed. Additional information is needed before the Executive Committee can approve a budget for recommendation to the Board of Supervisors. CAO staff will work with departments/agencies that have made requests to obtain additional information and prepare a budget packet for review by the committee.
