PURPOSE STATEMENT – Juvenile Justice Delinquency Prevention Commission

The mission of the Juvenile Justice Delinquency Prevention Commission (JJDPC) is to inquire into the administration of juvenile justice in Solano County. The overall objective is to reduce the recidivism rate of juvenile offenders in the local criminal justice system.

The Solano County JJDPC was established by the Solano County Board of Supervisors under authority of California Welfare and Institutions Code Section 233. Its predecessor organizations were the Juvenile Justice Commission, mandated by Section 225 of the W&I Code and the Delinquency Prevention Commission authorized by Section 233 of the W&I Code.

The duties and functions of the Commission are stated in Sections: 228, 229, 229.5, 230, 233, and 234 of the Welfare and Institutions Code

The JJDPC is granted access to all publicly administered institutions in Solano County authorized by the Juvenile Court Law. This includes annual inspections of probation-administered institutions, jails, and other lockups detaining juveniles.

Overview of Probation and the Juvenile Detention Facility: Solano County Probation has three main components, Adult division, Juvenile division and the Juvenile Detention Facility (JDF). JDF is a 120 bed facility built in 2004. At JDF there are 2 separate commitment programs, New Foundation for 4 months and The Challenge Academy which is a 9 month commitment program. Currently at JDF we have 13 youth on the Redwood Pod, 21 youth on the Sycamore Pod, 14 youth on the Sequoia Pod, 11 youth in the Challenge Academy and 11 youth in the New Foundations program.

Friday, May 6, 2016 at 10am, 7 of our youth will be receiving their high school diplomas at JDF. We welcome everyone to come and show support. The ceremony will take place in Cedar Hall at JDF. Please contact Kelley Baulwin-Johnson at 707-784-6570 if you would like to attend the graduation ceremony.

There will be an educational tour of Juvenile Hall held on Monday, May 16th at 8:15am for school administrators. We would welcome members of the Commission to tour as well. If you are interested in going on the tour, please send an e-mail to Tami attrrobinson@solanocounty.com so she can put your name on the list.

Public Comment Regarding the overview of Probation and the Juvenile Detention Facility: Mr. Vernon Williams III asked how one would be able to participate in the Tour on the 16th if they are not and educator or commissioner. Chief Hansen advised him to contact with Mrs. Baulwin-Johnson at JDF to coordinate outside participation.
