#### **PURPOSE STATEMENT – Community Corrections Partnership**

The mission of the Community Corrections Partnership (CCP) is to discuss issues related to the implementation of various pieces of state legislation that focus on adult criminal offenders, including the realignment of many state public safety functions to local jurisdictions. The overall objective is to reduce the recidivism rate of adult offenders in the local criminal justice system.

Membership of the CCP is outlined in California Penal Code section 1230 and defined by the Community Corrections Performance Incentive Act of 2009 (SB 678) and includes the Chief Probation Officer (Chair)\*, Presiding Judge of the Superior Court\* or his or her designee, a County Supervisor or County Administrator, District Attorney\*, Public Defender\*, Sheriff\*, the head of the Department of Social Services\*, the head of the County Department of Mental Health, the head of the County Department of Employment, the head of the County Alcohol and Substance Abuse programs, the County Superintendent of Education, a local chief of police\*, a representative of a community-based organization with experience in successfully providing rehabilitative services to persons convicted of criminal offenses, and an individual who represents the interests of victims.

Through AB 109/AB117 the CCP is responsible for recommending a local plan to the county Board of Supervisors (BOS) for the implementation of public safety realignment. This legislation also established an Executive Committee within the CCP. Each Executive Committee member is identified with an asterisk (\*) above. The Executive Committee is responsible for approving the local plan for recommendation to the BOS.

**Public Comment:** Deanna Allen announced that National Reentry Awareness Week is April 24<sup>th</sup>-30<sup>th</sup> and encouraged everyone to participate in some of the week's festivities. She left flyers on the table outlining the events taking place throughout the week.

#### **Approval of Minutes**

The motion of Sheriff Ferrara to approve the Minutes was adopted by the following vote: 8 in favor, 0 (zero) opposing and 1 abstaining.

**Data Report:** (See PowerPoint – Probation Department, Sheriff's Office and Health & Social Services Data Presentation April 21, 2016.)

- Dean Wilder presented statistical information pertaining to the Realignment population. He also gave information on the statistics pertaining to the success of our clients at the CPC.
- Amy Potter gave an update of the Pretrial program.
- Captain Denton Autry provided statistical information pertaining to the jail population as a result of Public Safety Realignment.
- Halsey Simmons presented statistical information regarding referrals and placements for AB109 offenders.

**Public Comments Regarding the Data Report:** Dr. Schussel suggested the importance of letting the public know what the AB109 programs have done for the clients over the 5 years span.

<u>Update on the 2011 Public Safety Realignment Plan:</u> Shawna Albright gave an update on the Probation piece of the 2011 Public Safety Realignment Plan to include changes in how clients are supervised in the Probation Department. The Department Policy related to Client Supervision (P100) was updated in February to include Early Termination recommendations.

#### Community Corrections Partnership Meeting Public Safety Local Plan Development Minutes April 21, 2016

Clients will continue to be supervised based on risk and Officers will utilize training in Motivation Interviewing & EPICS-II as well as refer clients to appropriate services to elicit positive behavior change.

In response to Non-Compliance, Officers utilize a graduated sanctions grid for PRCS clients to address technical violations in lieu of fling a petition for revocation with the Court. The grid will be expanded for use for all probation clients.

Regarding collaboration with other Agencies, the PRCS officers work closely with the Sheriff Enforcement Team (SET) on searches and high risk arrests as needed. The Sheriff's Office has also assisted with several trainings for Probation Staff to include Field Officer Safety trainings. In addition, supervision officers work collaboratively with the CPC caseworkers as well as several different treatment providers to ensure clients receive the services that they need.

Dean Wilder talked about the refinement of the CPC program. The Probation Department has focused on enhancing the services offered at the Centers for Positive Change to include gender specific groups, gender specific programming, housing, education and substance abuse services. There will be a CPC graduation on Wednesday, July 20, 2016 from 4pm-6-pm at the County Events Center.

Renee Smith highlighted the Sheriff's Office piece of the Implementation Plan to include more Case Management Services. The contract with Healthright 360 was approved in April 2016. Five (5) Case Managers will come on board in June 2016 and will be dispersed throughout the three (3) jails. The LS/CMI will be administered, case plans developed, DBT groups facilitated, and re-entry plans will be established with a 30 day follow up after release. Five Keys Charter School will be providing high school credits toward diplomas, GED preparation, English as a second language services, and special education. They are currently providing all services at Claybank and Stanton and special education services at JCDF. In July 2016 they will be providing all services at JCDF.

As far as the Employment Readiness piece, LCA is providing Classroom style Employment Readiness Services at Claybank to men and women who are then referred to continue employment services at the CPC after release. Also, the BSCC Recidivism Reduction contract with Michael's Transportation allows for five (5) individuals to be referred for truck driving training.

The Mentally Ill Offender Crime Reduction Grant (MIOCR) allowed the launch of the In-Custody treatment program in February 2016 as well as the Re-Entry/Aftercare program. The Community Based Diversion launched in March 2016 and the Post-Booking Diversion program continues to be in development.

<u>Update on the BSCC Community Recidivism Reduction Grant:</u> The committee received an update from the Ad Hoc subcommittee for the BSCC Community Recidivism Reduction Grant to include the status of the RFP. The RFP was posted Friday April 15, 2016 and will remain open until 5PM on Monday, May 23, 2016. The Ad Hoc subcommittee recommended the

committee give them authority to review the submissions in line with county policies and make the awards as the subcommittee deems appropriate.

The motion of Mr. Jay Speck to approve the recommendation was adopted by the following vote: 9 in favor, 0 (zero) opposing, and 0 (zero) abstaining.

**Public Comment Regarding the BSCC Community Recidivism Reduction Grant:** Dr. Schussel questioned whether or not \$25,000 was a sufficient amount for the vendors to be able to provide the services we are looking for and also inquired as to why there isn't a community member on the committee.

**Budget Update:** Ian Goldberg gave an overview of the2011 Public Safety Realignment Budget for FY 2016/17. The committee was asked to consider recommending to the Board of Supervisors programs and services that total \$15.3 million for FY 2016/17 utilizing AB109 funding.

The motion of Sheriff Ferrara to approve the recommendation was adopted by the following vote: 7 in favor, 0 (zero) opposing, and 1 abstaining.








## Jail Program Data January 1 –June 30, 2016







## Jail Program Data January 1-June 30, 2016

# Health & Social Services (HSS) Mental Health Services




- Integrated Care Clinics (ICC) provide initial mental health assessments and ongoing psychiatry services including monitoring medication, crisis intervention as needed, and light case management. The target population is Seriously Mentally III (SMI) adults who are appropriate for medication monitoring services. ICC sites are located in Fairfield, Vallejo and Vacaville.
- Non-Forensic Mental Health services may include private providers from the network of care, Full Services Partnerships (FSP) programs, or Case Management Programs.
- Forensic Assertive Community Treatment (FACT) is a Full Service Partnership (FSP) Program specializing in the provision of intensive mental health services to Seriously Mentally III (SMI) offenders. Services include intensive case management, individual and group therapy, psychiatry and medication monitoring, individual rehab, and crisis intervention as needed. FACT works closely with Probation and the Courts to monitor clients' progress.
- **Exodus Crisis Stabilization Unit (CSU)** provides crisis intervention for clients in acute crisis requiring further assessment for hospitalization. Additionally the CSU currently provides urgent medication refill services for clients at risk of hospitalization.
- Laurel Creek is a short term crisis residential treatment facility geared to be a step down from hospital settings and can be used to prevent hospitalization. Clients placed at Laurel Creek must be Seriously Mentally III and at imminent risk of destabilization without this support.
- Inpatient/Hospital facilities are used to stabilize clients who have become a danger to themselves, others, or are gravely disabled.



# Health & Social Services (HSS) Substance Abuse Services




- **Behavioral Health Assessment Team (BHAT)** assesses for acuity and level of care for substance using citizens of Solano County who are eighteen and older.
- **Outpatient Substance Abuse (SA) Treatment** is substance abuse treatment by a local provider, based on assessment. A typical program includes three 90 minute groups per week, an individual session and urine testing.
- **Detox** services are available 24 hours per day every day of the year and may last up to 15 days per episode.
- **Residential Substance Abuse (SA)Treatment** is for clients with multiple, serious needs (e.g. housing and support network) in addition to uncontrolled substance use may be authorized for residential treatment in which the client lives in the treatment facility for a period up to six months.





#### **DEPARTMENTAL RECOMMENDATION:**

The Ad Hoc Subcommittee recommends the Community Corrections Partnership:

- 1. Consider the three (3) recommendations provided by the Ad Hoc Subcommittee regarding the allocation of the remaining funds of \$25,000;
- 2. Direct the Ad Hoc Subcommittee to move forward with the recommendation selected by the CCP to administer the remaining funds.

#### SUMMARY / DISCUSSION:

In Fiscal Year (FY) 2014/2015, the CCP received \$100,000 for the administration of the Community Recidivism Reduction Grant. Per California Penal Code section 1233.10, grants under this program must be awarded to a nongovernmental entity or a consortium or coalition of nongovernmental entities that provide community recidivism and crime reduction services to persons who have been released from state prison, a county jail, or a juvenile detention facility, who are under the supervision of a parole or probation department, or any other person at risk of becoming involved in criminal activities. Community recidivism and crime reduction services include, but are not limited to delinquency prevention, homelessness prevention and reentry services.

As a result of an RFP, four (4) community based organizations received funding in the amount of \$25,000 to provide services: Mission Solano, Mount Calvary, Michael's Transportation and Bethel Community Church. In FY 2015/2016, the CCP received an additional \$50,000, therefore, the Ad Hoc Subcommittee participated in another RFP in order to allocate the funds. The subcommittee met on June 13, 2016 and July 21, 2016. The Ad Hoc Subcommittee reviewed proposals from Ebenezer Outreach, Abundant Place and Changing Criminal Behaviors Consulting Services (CCBCS). Based on the evaluation process, the Ad Hoc Subcommittee awarded \$25,000 to CCBCS. The CCBCS will provide services to include a sober living home to six (6) men upon their release from the California Department of Corrections and Rehabilitation or the Solano County Jail. As a result of this award, there is \$25,000 remaining from the total allocation. In order to address the remaining funds, the Ad Hoc Subcommittee reviewed three (3) options and is recommending that the CCP consider the options noted and provide direction to the Ad Hoc Subcommittee. The three (3) options are as follows:

1. Issue another RFP for the remaining \$25,000 to possibly include micro grants up to \$10,000.

- Look at existing providers that have received funding and give an additional allocation of \$25,000 based on performance (Michael's Transportation has served 3 out of 5 clients in year 1).
- 3. Return the remaining \$25,000 to the State.

#### FINANCIAL IMPACT:

The total fuds allocated to Solano County under the Community Recidivism Reduction Grants is a one-time award of \$150,000. These funds, once allocated, are to be made available for expenditure for a period of three years and any unexpended funds shall revert to the state General Fund at the end of the three year period. Any funds not encumbered with a community recidivism and crime reduction service provider one year after allocation of grant funds to counties shall immediately revert to the state General Fund. Individual awards to any community recidivism and crime reduction service provider cannot exceed \$25,000 as outlined in the Penal Code.

These funds are included in the Probation Department's AB109 revenue for FY2016/17. There is no anticipated General Fund impact associated with approval of this action.

#### ALTERNATIVES:

The CCP could choose not to follow the recommendations from the Ad Hoc Subcommittee and recommend another alternative. This is not recommended as the CCP delegated the decisions related to the allocation of funding to the Ad Hoc Subcommittee. The Ad Hoc Subcommittee also does not recommend option three (3) due to the fact that it entails returning money back to the State that could be put to good use in Solano County by providing services/resources to adults and juveniles in the justice system.

#### **OTHER AGENCY INVOLVEMENT:**

The County Administrator's Office, Sheriff's Office, and the Probation Department have reviewed this item and the related recommendations.

#### **RECOMMENDATION:**

It is recommended that the Community Corrections Partnership (CCP): Consider authorizing the Chair to establish an Ad Hoc Committee to develop recommendations on achieving a necessary budget reduction strategy for FY2017/18 and beyond to address the reduced level of available AB 109 funding.

#### SUMMARY:

The 2011 Public Safety Realignment Act (AB 109 and companion legislation) realigned from the State of California (State) to counties specific duties and responsibilities in the criminal justice system including, supervision of individuals convicted of felony offenses, changing the role of counties. The State in turn allocated funds to counties to address these new duties and responsibilities.

As previously communicated to the CCP, the State funding is insufficient to address the costs of AB 109 programs and services in Solano County Departments designed to implement the requirements of AB 109 and related legislation. To temporarily address the funding shortfall Solano County has relied on unspent carryforward revenue from previous years. As projected in the FY2016/17 Requested Budget the unspent carryforward revenue of AB 109 funds will be exhausted in FY2017/18. To address the projected ongoing funding shortfall in FY2017/18 and beyond, the Community Corrections Partnership will need to revisit its plans, programs and services, and recommend prioritization and changes/reductions to align appropriations for programs and services with ongoing revenues.

To address the projected AB 109 budget shortfall it is recommended that the CCP authorize the Chair to establish an Ad Hoc committee to evaluate existing programs and services in coordination with the respective Departments receiving AB 109 funding. It is recommended that the Ad Hoc Committee consist of a representative from the Probation Department, Sheriff's Office and H&SS, and the committee be supported by staff from the County Administrator's Office. The Ad Hoc Committee would be chaired by a member of the CCP Executive Committee.

The Ad Hoc Committee will gather information and outcome data, where available and review and provide recommendations to the CCP at the January 2017 meeting, at which time the CCP can provide input and direction to be considered in preparing the FY2017/18 Requested Budget.

#### FINANCIAL IMPACT:

The FY2016/17 AB 109 Budget approved by the Board in June 2016 totals \$15.3 million in appropriations. The appropriations are funded by an estimated State revenue allocation of \$12.2 million and rely on the use of unspent carryforward from prior years to fund the remaining \$3.1 million shortfall.

The projected FY2017/18 AB 109 Budget, assuming spending and state revenue projections remain flat, results in a budget of \$15.3 million in appropriations and \$12.2 million in revenue from the State allocation. The County would be facing a shortfall of \$3.1 million in AB 109. The remaining balance in unspent carryforward funds which could be used to address this shortfall in FY2017/18 is \$1.8 million, resulting in a net shortfall of \$1.3 million.

Assuming projected spending and state revenue projections remain flat in subsequent years, and that the County has exhausted all Carryforward funds the ongoing AB 109 funding shortfall is approximately \$3.1 million per year. This assumes no increase in program and service costs including employee costs, such as retiree or medical costs which are anticipated to continue to increase in future years. As such the actual shortfall is anticipated to be greater than \$3.1 million in future years.

Based on current projections the Ad Hoc Committee would need to develop recommendations for a budget reduction strategy to achieve a minimum of \$1.3 million in FY2017/18 and \$3.1 million in future years.

#### **DISCUSSION:**

#### Background

The 2011 Public Safety Realignment Act (AB 109 and companion legislation) redirected from the State of California (State) to counties specific duties and responsibilities associated with the sentencing and supervision of individuals convicted of felony offenses. This legislation changed sentencing practices, shifted responsibility for the housing of convicted non-violent offenders and parole violators to the counties, and shifted responsibility for supervising paroled non-violent, non-serious, and non-sex (non-non-non) offenders to county probation departments.

The Board of Supervisors, in compliance with the new mandates, approved the Solano Public Safety Realignment Act Implementation Plan on November 1, 2011 (2011 Plan) as prepared and recommended by the CCP. Since November 2011, the Board of Supervisors has received reports and recommendations from the Solano Community Corrections Partnership (CCP) on the timing and sequencing of the implementation of the 2011 Plan. The Board has approved a number of new positions, professional service and consultant service contracts, training, equipment purchases and other related expenses needed to support the implementation of the approved 2011 Public Safety Realignment Plan.

Solano County Departments have included continued funding in full for the programs and services previously supported by the CCP for FY2016/17.

AB 109 programs and services are funded through an allocation of statewide Vehicle License Fees and a portion of the State sales tax. The State allocation of AB 109 for Solano County consists of a base allocation and an allocation based on a formula to allocate growth in the State funding source. AB109 growth funds for Community Corrections are dependent on the State's sales tax and VLF collections and are allocated based on performance measures primarily on incarceration rates and Probation success rates. The growth estimates in the FY2016/17 Requested Budget reflect allocations in the "Probation Success" and "Low Rate of Incarceration" categories, and no allocation in the "2<sup>nd</sup> Striker Reduction", "Probation Improvement" and Incarceration factors in respect to the success factors and resulting funding in Solano County and will update the Community Corrections Partnership at a future meeting when the results are complete.

#### ALTERNATIVES:

The CCP could choose not to authorize the Chair to establish an Ad Hoc Committee to develop and provide recommendations to address the AB 109 funding shortfall. This is not recommended as it would limit the CCP ability to make informed decisions regarding the FY2017/18 budget.
