#### **PURPOSE STATEMENT – Community Corrections Partnership**

The mission of the Community Corrections Partnership (CCP) is to discuss issues related to the implementation of various pieces of state legislation that focus on adult criminal offenders, including the realignment of many state public safety functions to local jurisdictions. The overall objective is to reduce the recidivism rate of adult offenders in the local criminal justice system.

Membership of the CCP is outlined in California Penal Code section 1230 and defined by the Community Corrections Performance Incentive Act of 2009 (SB 678) and includes the Chief Probation Officer (Chair)\*, Presiding Judge of the Superior Court\* or his or her designee, a County Supervisor or County Administrator, District Attorney\*, Public Defender\*, Sheriff\*, the head of the Department of Social Services\*, the head of the County Department of Mental Health, the head of the County Department of Employment, the head of the County Alcohol and Substance Abuse programs, the County Superintendent of Education, a local chief of police\*, a representative of a community-based organization with experience in successfully providing rehabilitative services to persons convicted of criminal offenses, and an individual who represents the interests of victims.

Through AB 109/AB117 the CCP is responsible for recommending a local plan to the county Board of Supervisors (BOS) for the implementation of public safety realignment. This legislation also established an Executive Committee within the CCP. Each Executive Committee member is identified with an asterisk (\*) above. The Executive Committee is responsible for approving the local plan for recommendation to the BOS.

#### **RECOMMENDATION:**

It is recommended that the Community Corrections Partnership (CCP):

- 1. Receive an update on the 2011 Public Safety Realignment Budget; and
- 2. Consider recommending to the Board of Supervisors a reduction in preliminary expenditures of \$13.9 million by 10% for programs and services for FY2020/21, funded by a new estimated allocation of \$11.1 million and estimated unspent carryforward funds of \$1.3 million in 2011 Public Safety Realignment revenue (AB109) to continue to advance concepts in the adopted 2011 Public Safety Realignment Act Implementation Plan.

#### **SUMMARY:**

#### Background

The 2011 Public Safety Realignment Act (AB 109 and companion legislation) redirected from the State of California (State) to counties specific duties and responsibilities associated with the sentencing and supervision of individuals convicted of felony offenses. This legislation changed sentencing practices, shifted responsibility for the housing of convicted non-violent offenders and parole violators to the counties, and shifted responsibility for supervising paroled non-violent, non-serious, and non-sex (non-non-non) offenders to county probation departments.

The Board of Supervisors, in compliance with the new mandates, approved the Solano Public Safety Realignment Act Implementation Plan on November 1, 2011 (2011 Plan) as prepared and recommended by the CCP. Since November 2011, the Board of Supervisors has received reports and recommendations from the Solano Community Corrections Partnership (CCP) on

the timing and sequencing of the implementation of the 2011 Plan. The Board has approved a number of new positions, professional service and consultant service contracts, training, equipment purchases, and other related expenses needed to support the implementation of the approved 2011 Public Safety Realignment Plan.

Solano County Departments have included continued funding for the programs and services previously supported by the CCP for FY2019/20 in their requests, but available funding is at a reduced level due to lower sales tax revenue after the COVID-19 shelter at home orders and high unemployment rates. An overview of the respective Departments FY2020/21 programs and related costs, as well as recommended reductions, are outlined in the Discussion section herein.

#### **FINANCIAL IMPACT:**

2011 Public Safety Realignment funding from the State for Community Corrections consists of an annual base allocation and a possible growth allocation, which is based on a formula to share growth in the State funding source. The growth funds are dependent on the State's sales tax and VLF collections and are allocated based on performance measures primarily on incarceration rates and Probation success rates. The 2011 Public Safety Realignment fiscal year period is August 16 through August 15.

#### FY2019/20

The Requested Budget for FY2019/20 included requested expenditures of \$14.2 million, and estimated revenues of \$13.5 million in State base allocation and an estimated \$2.9 million in unspent carryforward from previous years for total estimated available funds of \$16.4 million. Through the budget process for both FY2019/20 Adopted and Mid-Year Budgets, the approved expenditures decreased to \$13.1 million and departments are on track to meet the revised budgetary amounts at year-end. However, due to the COVID-19 shelter at home orders and high unemployment rates, the Governor's May Revision of the State's FY2020/21 budget indicated that 2011 Public Safety Realignment will not be fully funded at the expected level. The California State Association of Counties (CSAC) projects that the revised base amount for FY2019/20 for Solano will be \$10.9 million, with no growth allocation.

While the 2011 Public Safety Realignment fiscal year does not end until August 15 and therefore numbers remain fluid, should these projections be in-line with actual funding, expenditures will exceed the base allocation and will rely substantially on an increased amount of the estimated unspent carryforward to cover the deficit, as there is insufficient time left in the fiscal year to make any significant reductions for FY2019/20. The current balance of the carryover would be enough to cover this deficit; however, this would reduce the balance of unspent carryover available for FY2020/21.

#### FY2020/21

The Preliminary Requested Budget for FY2020/21 includes expenditures of \$13.9 million, which exceeds the estimated State allocation of \$11.1 million (as projected by CSAC based on the Governor's May revision) and estimated available unspent carryover of \$1.3 million if the FY2019/20 projections are realized. This does not include the subaccount and planning grant allocation. The impacts of the COVID-19 shelter at home orders and high unemployment rates are expected to continue well into the FY2020/21, and with no growth allocation expected for a

second year. Because the growth allocation is replied retroactively, the lack of growth in FY2019/20 would impact FY2020/21. As a result, staff estimates a deficit of \$2.8 million for FY2020/21.

In order to reduce this deficit, reductions in proposed expenditures of 10% must be implemented by each department for the entire FY2020/21 fiscal year. Staff will continue to closely monitor the State Budget and sales tax/vehicle license fee revenues and recalculate the deficit upon receipt of the final FY2019/20 2011 Public Safety Realignment funding to determine if a lesser reduction can be implemented through the Supplemental Budget process. However, to balance the budget for recommendation for approval by the Board of Supervisors, 10% reductions must be included in the preliminary recommendation.

#### **DISCUSSION:**

The FY2020/21 Preliminary Recommended Budget for 2011 Public Safety Realignment is \$13.9 million, which represents an increase of \$356,655 from the FY2019/20 Adopted Budget. This increase is primarily due to an increase in jail programming and staffing costs of \$243,202 and a net increase of \$55,859 in Probation. Other departments or budget units reflect increases and others decreases, resulting in the net increases.

The following are summaries of the programs and services included in FY2020/21 Preliminary Recommended Budgets for the respective Departments. The funding totals represent the full costs to deliver 2011 Public Safety Realignment program services previously recommended by the CCP in accordance with the 2011 Plan. The summary includes the amount of a 10% reduction for each department.

#### District Attorney

The 2011 Public Safety Realignment (AB 109) imposed legal responsibilities on prosecutor's offices, including the prosecution of revocations of Post-release Community Supervision (PRCS). For FY2020/21, the District Attorney (DA) has requested \$770,295 of AB 109 funding to continue staffing positions and funding costs to address prosecuting duties under AB109. A 10% reduction of \$77,030 is recommended.

#### Public Defender

The 2011 Public Safety Realignment (AB 109) imposed legal responsibilities on the Public Defender's office, including the representation of revocations of Post-Release Community Supervision (PRCS) and parole violations. For FY2020/21, the Public Defender (PD) has requested \$645,280 of AB 109 funding to continue staffing positions and funding costs to continue the work under AB 109. A 10% reduction of \$64,528 is recommended.

#### Alternate Public Defender

The 2011 Public Safety Realignment (AB 109) imposed legal responsibilities on the Alternate Public Defender's office, including the representation of revocations of PRCS. For FY2020/21, the Alternate Public Defender has requested \$48,842 of AB 109 funding to continue staffing positions and funding costs to support AB 109. A 10% reduction of \$4884 is recommended.

#### Sheriff's Office

For FY2020/21 the Sheriff's Office has requested \$5,723,422 of AB 109 funding. In addition to personnel costs, the Sheriff is requesting a continuation of offsetting Realignment Funds to cover AB109 inmate related costs, such as inmate meals, medical treatment, and other detention facility costs related to the AB109 inmate population, which typically accounts for over 20% of the County Jail population. A 10% reduction of \$572,342 is recommended.

#### **Probation Department**

To meet the mandates under the 2011 Public Safety Realignment (AB 109) for FY2020/21, Probation is proposing to continue the same level of staffing and programs for 2 re-entry centers and supervision of PRCS and 1170h split sentences, this ongoing effort is estimated to be \$6,324,515 of AB 109 funding. To address its 2011 Realignment requirements the Probation Department maintains staffing in order to manage the caseloads of PRCS and to operate the Centers for Positive Change (CPC) in both Vallejo and Fairfield, which includes providing Substance Abuse services and Mental Health Clinician services. A 10% reduction of \$632,452 is recommended.

#### **Health & Social Services**

To meet its FY2019/20 mandates under the 2011 Public Safety Realignment (AB 109), Health & Social Services (H&SS) has requested \$259,108 of AB 109 funding to continue staffing positions and funding costs for Mental Health and Substance Abuse treatment and programs. A 10% reduction of \$25,911 is recommended.

#### Planning and Administration:

In meeting mandates under 2011 Public Safety Realignment (AB 109) the FY2020/21 Preliminary Recommended Budget includes \$150,000 of AB109 funding to cover expenditures for planning and administration. This request includes partial funding for the Superior Court of California County of Solano Limited Term Collaborative Court Manager (CCM) and 1/3 of the annual cost of the Veterans Court Case Manager. Additionally, the preliminary budget includes funds for data analysis and research and planning services. A 10% reduction of \$15,000 is recommended.

Departments receiving 2011 Public Safety Realignment funding were unaware of the impacts COVID-19 would have on the budget in general, and specifically 2011 Public Safety Realignment, at the time they submitted their requested budgets and were unable to make any adjustments. During the extended Supplemental Budget process, staff will continue to track 2011 Public Safety Realignment allocations and work with departments on their budgets, to keep appropriations in alignment with revised estimated revenues, while still striving to implement as many of the requirements of the 2011 Plan as possible.

The County must have an approved budget prior to July 1, 2020 to comply with State law and to enable the County to expend any funds after June 30. A Preliminary Recommended Budget for FY2020/21 will be presented to the Solano County Board of Supervisors in June 2020, followed by a comprehensive Supplemental Budget process to arrive at a final version of the FY2020/21 budget to be considered by the Board in September. The 2011 Public Safety Realignment

budget is a component of the County's overall budget, and preliminary recommendations for Board approval must be included.

#### **ALTERNATIVES:**

- 1. The CCP could choose not to receive an update on the 2011 Public Safety Realignment Budget. This is not recommended as it would limit the CCP's ability to make informed decisions regarding the FY2020/21 Preliminary Recommended Budget.
- 2. The CCP could choose not to support a 2011 Public Safety Realignment budget recommendation to the Board of Supervisors that fully expends the balance of the unspent carryforward to support programs and services that total \$13.9 million subject to 10% reductions for FY2020/21 to continue to advance concepts in the 2011 Plan. This would require reductions to program and service levels and/or staffing. This is not recommended as the CCP has previously adopted the 2011 Plan and not supporting the appropriation of all available funding would limit the County's ability to implement the 2011 Plan to the greatest extent possible.

#### **Approval of Agenda**

#### **Approval of Minutes**

#### **AB109 Funds**

The Committee was asked to consider a recommendation to utilize up to \$60,000 in AB109 planning fund annual allocation to support the County's participation in funding a feasibility study of a Regional Correctional Mental Health Facility.

#### **Recidivism Cohort Study**

Chief Hansen gave an update on the Recidivism Cohort Study conducted by the Probation Department in partnership with Beyond the Arc. (*See PowerPoint—Status Update: Adult Recidivism Study*)

#### **Results First**

Jen McDermott gave a brief update on the progress of the Results First Initiative and asked the Committee to consider a recommendation to establish an Ad Hoc Sub-committee to focus on evidence-based programs in alignment with the Results First Initiative.

The motion of Sheriff Ferrara to approve the recommendation was seconded by Heather Henry and adopted by the following vote: 9 (nine) in favor, 0 (zero) opposing and 0 (zero) abstaining.

#### **CCP Survey**

Chief Hansen informed the committee that they will receive a survey to solicit their thoughts and ideas for future CCP meetings. The survey will be issued in November and the results will be discussed at the CCP meeting in January.

#### **CCP Graduation**

Katie Ward reported that the Centers for Positive Change (CPC) graduated 72 clients this year and they were recognized at a ceremony held on September 4<sup>th.</sup> She shared pictures of the event and commented on the impact that positive and supportive relationships have on a client's success in completing programming.

#### Transition from Jail to Community (TJC) Initiative

Renee Smith and Katie Ward presented an overview of Transition from Jail to Community (TJC), a National Institute of Corrections technical assistance project that helps local jurisdictions improve reentry processes and utilize evidence-based tools to ensure inmates in the county jail receive appropriate programming and discharge planning based on their risk and needs. The project focuses on the systems that connect the jail and the community to create strategic continuums of care as justice involved people reintegrate, connect with community corrections, and access services. Solano County is a recipient of the technical assistance grant and a team of county agency staff are moving the project forward. The TJC team is looking to the CCP to consider formalizing the committee and providing executive leadership to the project. Further discussion and a recommendation to consider will be prepared for the next CCP meeting.

#### Narcan

The Committee watched and discussed the Dr. Waller video called Addiction Neuroscience 101, to introduce CCP members to the statewide work around Medically Assisted Treatment (MAT), including Narcan.

#### Rise Together Fair Chance Workshop Project

A joint presentation was made by Heather Henry with the Workforce Development Board (WDB) and Deanna Allen with Abundant Place regarding updated efforts and goals of the SISN coalition. Formed earlier this year, SISN - Systems Impacted Solano Network, has grown to over 90 partners including many with lived experience. The presentation included the identified primary goals and upcoming objectives of SISN; including a recent commitment to be the Solano County working task-force in collaboration with the Rise Together Insight Center for Community Development and Urban Strategies Council. The group will utilize data and recommendations found in their executive report of the Bay Area focusing on Alameda, Contra Costa and Solano County. A customized report focusing on the Solano County report findings was shared. The full report can be found at RiseTogetherBayArea.org/FairChance.
