



WHO'S ON MY PROPERTY?

Did you sign a Right-of-Entry form to have your property cleaned by the state's Consolidated Debris Removal Program? If so, you may see many different teams on your property over the next weeks and months.

Each team has a specific job, but they share the same goal: to leave your property clean and safe.

All legitimate program staff will have an identifying placard in their vehicle and will be wearing appropriate safety equipment.

Following the removal of household hazardous waste, here is who you will see on your property and what they will be doing:

Property Assessment and Monitoring Team

CalRecycle oversees private consultants who monitor, document and report all activities for the cleanup project. Operating under a separate contract than debris and tree removal teams, consultants provide independent, third-party documentation of all work done on your property. Consultants also test properties for asbestos prior to debris removal, and sample soil for heavy metals after contractors have removed the structural debris.

The Assessment and Monitoring consultant employs subcontractors to ensure compliance with local, state and federal requirements. Subcontractors may include:

- Registered professional foresters and certified arborists
- Biologists and environmental monitors
- Surveyors
- Archaeologists and cultural monitors

Wildfire Debris and Hazard Tree Removal Team

CalRecycle oversees debris removal contractors and licensed timber operators to remove wildfire debris from your property. All removal crews will be accompanied by a representative of the Assessment and Monitoring consultant to provide an independent record of activities.

The debris and tree removal contractors employ subcontractors that may include:

- Other debris removal subcontractors or licensed timber operators
- Traffic control teams
- Dust control operators such as street sweepers
- Truck drivers
