ABOUT SOLANO COUNTY BEHAVIORAL HEALTH

SOLANO MENTAL HEALTH PLAN AND SOLANO DRUG MEDI-CAL PROGRAMS

Solano County Behavioral Health is responsible for implementing and overseeing the operations of both the Solano Mental Health Plan and Solano Drug Medi-Cal Program.

- Solano Mental Health Plan (MHP): This healthcare system provides specialty mental health services for individuals who are experiencing significant mental health symptoms, and who have Solano County Medi-Cal or are uninsured.
- Solano's Drug Medi-Cal Program (DMC-ODS): Solano's DMC-ODS Program is managed by Partnership Health Plan of California with substance use treatment services provided through Beacon Health Services for individuals with Solano County Medi-Cal, and with prior authorization, for individuals without insurance.

WHAT IS AN ACCESS LINE??

The purpose of the Access Line is to make sure you are being referred to the appropriate services based on your individual needs. The Access representative will work with you to find out if you have mental health needs, substance use treatment needs, or some other needs and provide a referral so you can start accessing care.

WHAT HAPPENS WHEN I CALL THE SOLANO ACCESS LINE?

A Solano Access representative will greet you and begin the conversation by first determining if you are experiencing an emergency that requires an immediate response. If that is not the case, the representative will ask questions such as:

- Demographic information (name, date of birth, gender, etc.)
- Insurance information (Solano County Behavioral Health programs specifically serve those with Solano County Medi-Cal, Medicare and the uninsured)
- Current mental health symptoms and/or substance
 use problems
- Information about how your life being impacted
- An access screening can take up to 20-30 mins, depending on your needs

NEXT STEPS

After your screening is finished, your Access Line representative will determine what system of care makes the most sense for you and make the appropriate referrals. Such referrals will either be for an assessment for mental health or substance use treatment from a Solano County Behavioral Health program, or a referral to another provider entity.

The Solano County Behavioral Health MHP provides behavioral health services—mental health and substance use treatment—for both children and adults. While services are delivered for consumers living throughout the County there are outpatient clinics operated by County and contract partners located in Vallejo, Fairfield, Rio Vista and Vacaville. Additionally, there are programs that travel to schools and other regions of the County to provide services.
