PURPOSE STATEMENT – Juvenile Justice Coordinating Council Subcommittee

The JJCC Subcommittee is necessary for the County to be eligible for Juvenile Justice Realignment Block Grant program funding identified in section 1991 of the Welfare and Institutions Code.

Update on Probation Internal Committees

<u>JDF</u>

The Community Safety workgroup is looking at conditions of confinement, such as food, clothing and aesthetics of the facility to create a more homelike environment. This group will also look at equipment needs for staff and youth to help the two work more collaboratively and ensure that everyone is on the same page.

The Programs and Services workgroup is looking at possible recommendations for expansion and modification of CBT 2.0 for Realigned youth, modifications to Behavior Management System and youth incentives, expanded educational and career preparation opportunities, expanded vocational/leadership training opportunities, independent living skills and transition planning, family engagement and counseling, integration of Transitional Services person as well as JDF staff training.

Court and Supervision

The Court and Supervision workgroup will meet on February 4th to discuss the next steps.

Reentry

The Reentry workgroup met on 1/14/21 to discuss a draft programming document. The workgroup discussed evidence-based practices and barrier removal ideas.

Next Steps/Future Meeting Dates

Once the shell of the report is formed it will be shared with the Subcommittee to review and make comments or suggestions.
