REALIGNMENT PLAN AND JUVENILE JUSTICE ACTION PLAN

County Realignment Plan

- Required to Be Developed by a Subcommittee of the Multiagency Juvenile Justice Coordinating Council in Order to Receive Funding
- Plan Needs to Describe the Facilities, Programs, Placements, Services, Supervision, and Reentry Strategies Needed to Provide Appropriate Rehabilitation and Supervision Services for Realigned Youth
- Narrow Scope Focus on Realigned Youth

Juvenile Justice Action Plan

- Independent Review of the Juvenile Justice Continuum of Care Within Solano County
- Includes a Three-Year Delinquency Prevention Plan
- Includes Proposed Strategies for Addressing Unmet Needs
- Broad Scope Focus on Entire Juvenile Justice Continuum
- Timeframe April 2022

OVERVIEW OF SB823 LEGISLATION INTENT OF LEGISLATION

Intent of Legislation

- Keep Youth Closer to Home/Families
- Provide Localized Access to Age-Appropriate, Culturally-Responsive, Trauma-Informed, Evidence-Based Treatment and Services
- Improve Outcomes for Youth
- Reduce the Transfer of Youth into the Adult CJ System
- Ensure Youth Are Placed in the Least Restrictive Appropriate Environment

Ultimate Intent/Impact

- Reduce, and Then Eliminate Racial and Ethnic Disparities
- Reduce the Use of Confinement in the Juvenile Justice System

<u>Creation of the Juvenile Justice Coordinating Council and County Realignment Plan</u>

A JJCC Subcommittee Required to Develop a Plan Describing the Necessary:

- Facilities
- Programs
- Placements
- Services
- Supervision
- Reentry Strategies

to Provide Appropriate Supervision and Rehabilitation Services for the **Realigned** Youth.

Funding

- Year One (FY21/22) \$496,773
- Year Two (FY22/23) \$1,471,567
- Year Three (FY23/24) \$2,437,942


