# **Year-Round Services for Veterans in Solano County**

The North Bay Stand Down is a three-day encampment for homeless and/or at-risk veterans and has been serving veterans since 2002. This year's event will be hosted on Oct. 14, 15 and 16 at the Dixon Mayfair.

Sponsored by Solano County's Health and Social Services Department, the event has served more than 2,200 vets, connecting them with local resources, including assistance with more than 1,700 court cases, the issue of 433 DMV ID cards and distribution of 23,000 pieces of clothing and bedding. Drawing vets from neighboring Yolo, Lake, Mendocino, Alameda, Contra Costa, Sacramento and San Francisco Counties, it takes an army of 5,000 volunteers help make this annual event a success.

Although veterans are provided with medical, dental, vision, housing, employment, recovery and other social services at the North Bay Stand Down event, it is important to note that veterans in Solano County have access to these services all year-round.

The Solano County Veterans Service office provides veterans and their families with a variety of programs and services relative to federal, state and local benefit programs based on military service. In addition to the services provided in our office, we connect veterans to other County services, including:

## **Child Support Services**

#### **Court Services – Veterans Treatment Services**

Starting Sept. 24, the Solano County Courts will begin a Veterans Treatment Court that will be a hybrid of drug and mental health courts. The court will use a drug court model to best serve the veteran population, connecting them with the drug, alcohol and rehabilitation programs they may need. ## **Health Insurance, Food and Cash Assistance**

The Solano County Community Action North Bay (CAN-B) offers three veteran specific housing programs throughout the County, including:

Mission Solano Veterans Transitional Housing Program (Bridge to Life Program) provides transitional housing to Veterans and Veterans families. There are also 10 emergency beds for Veterans who are VHA eligible – This is a 90 day program. The facility is located at 310 Beck Ave. in Fairfield. Call (707) 422-1011 for more information.
