Goal setting for 2018- Discussion about Sol Agra project, will be discussed under the Renewable Energy Group. Proposed crop(s) so far- alfalfa and less than a dozen others. Still waiting for project design before the committee can give a recommendation. Committee decided that there was a need for last years' goals to be reviewed so it can be more fully discussed/memory can be jogged/creative juices flowing at 2018 goals at the February meeting Possible: labor issues, migrant workers, marijuana regulations (currently a moratorium is in place for production in the county, but the various cities have their own regulations). Maybe getting a handle on all of the different aspects of what all the aspects of the marijuana business are. BY THE END OF THE year, we'd be able to offer a well rounded amount of advice to the Supervisors should they ask. There's also interest in hemp processing/growing- both fiber and seed. CDFA is currently developing a hemp pilot program.

Does the committee want to have farm tours again? Past issue has been lack of funding for transportation and lots of work to do the tour.
