NAPA SOLANO AREA AGENCY ON AGING BREAKFAST FOR PROVIDERS

On August 1st, the AAA and I hosted a breakfast for providers to inform them on what is required to be a vendor with the AAA. We want to make sure that our providers know what is needed to provide excellent services to our seniors. I am extremely proud of the work of our Solano County staff in restoring the AAA and ensuring our seniors continue to receive services.

FAIRFIELD VICE-MAYOR PAM BERTANI TOWNHALL

On August 3, I went to Vice-Mayor Pam Bertani's townhall at Fairfield City Hall. Many topics were discussed with the community members present. Vice-Mayor Bertani provided information on what Fairfield is doing to solve homelessness.

One of the strategies is implementing Laura's Law. Laura's Law provides for court ordered treatment of those with severe and persistent mental illness. I brought Laura's Law to the Board of Supervisors in January for adoption. I was supported by a Broad coalition that included the City of Vallejo, Assemblymember Jim Frazier, the Solano Courts, the Sheriff, County Health and Social Services, the Solano Mental Health Advisory Board and others. I am so thankful to see that Laura's Law is being utilized.

I am very thankful to Vice-Mayor Bertani for holding this event to keep the community informed. I look forward to more opportunities for the city and the county to collaborate.

HOMELESSNESS AND AFFORDABLE HOUSING

During a discussion on adopting impact fees for new construction at the August 6 Board of Supervisors meeting, I requested that we be presented with options on homelessness and affordable housing. Specifically, the county has \$1.6 Million in reserve for affordable housing. I requested that the Board be presented with options on how to utilize this resource.

NATIONAL NIGHT OUT

National Night Out on August 6th was a blast! My first stop was to the Cordelia Community Park where I ran into many people I knew. I am very thankful to Cordelia resident Nora Dizon for inviting me.

After Cordelia, I went to Mare Island. They were serving ice cream from Lileds! Lileds is a local Vallejo candy shop that has been in Vallejo since 1936. They have delicious homemade ice cream! It's located on Tennessee St.

HOME ENTERPRISE

At the August 13th Board meeting, I told the county staff that I wanted a discussion on permitting the home enterprise program in Solano County. I previously brought this up at the July 23 meeting. I have requested this be placed on the agenda in October.

The home enterprise program allows for the preparation of a relatively small number of meals to sell through a home kitchen. I believe this would be a good way for people in the community to operate their own business.

RODRIGUEZ HIGH SCHOOL MUSIC PARENT NIGHT

It was great to see so many families at the RHS music parent night on Thursday August 15. I was happy to be able to contribute \$1,000.00 to the music program. Both of my own children went to RHS and many of my former students attended RHS.
