V. Financial Plans Approval

Motion: Approve the 2023 Long-Term Financial Plan and 2023-2028 Program Investment Plan

Susan Brutschy, of Applied Survey Research, presented First 5 Solano's Long Term Financial Plan and Program Investment Plan. The Long-Term Financial Plan (LTFP) is meant to provide long-term policies and projections for funding priorities and key functions include: forecasts funding by type of revenue or expense, quantifies amount of program investment each year, establishes policies on use of financial resources. The LTFP is meant to encompass planning for 10 years. The Program Investment Plan (PIP) communicates how funds will be allocated toward strategies that contribute to strategic goals and results and key functions include: reviews recent allocations against LTFP policies, directs program investment funds to initiatives aligned with strategic priority areas, goals, and results, and provides a timeline for funding. The PIP is meant to align with the Strategic Plan and generally lasts 5 years.

First 5 Solano ED Harris discussed the next steps that the Commission needs to take in

regards to these plans; beginning in January 2023 solicitations for services occurs, in March 2023 the Commission budget will be approved, in April of 2023 the Commission will consider funding awards and contract negotiations will begin, in July 2023 services will begin.

VI. **Legislative Platform Approval**

First 5 Solano Program Manager Lorraine Fernandez presented on the 2023 Legislative Platform. In preparing the 2023 Legislative Platform, First 5 Staff reviewed the 2022 Legislative Platform, reviewed the Solano County Federal and State level 2023 Platforms as well as the Policy Platform from the First 5 Association. One change made to the 2023 Platform is the narrative, in which the impacts of Proposition 31 (the ban of flavored tobacco) are discussed and how additional resources can be increased. Early estimates of this ban indicate \$300,000 per year financial loss for the Commission.
