Family Disturbance Leads to Arrest and Recovery of Stolen Vehicle

On Friday, August 21, 2015, Sheriff's Dispatch received a call from a woman stating her son, later identified as 35 year old suspect Jacob Harris, was causing a disturbance inside the home. The caller stated Harris made threats to fight law enforcement if they responded. When deputies arrived to the 7400 block of Locke Road, Vacaville they were confronted by Harris who was exiting the house.

Harris was holding a hammer and raised it to shoulder level in a threatening manner. Deputies repeatedly ordered Harris to drop the hammer, to which he refused. He then dropped the hammer after several seconds and immediately took a fighting stance, challenging deputies to fight him. Harris refused to get on the ground and continued to challenge deputies. A taser was deployed, allowing deputies to take Harris into custody without further incident.

During this investigation, deputies located a stolen box truck nearby. The truck had been reported to the West Sacramento Police Department as stolen during a burglary earlier that morning. Harris was in possession of the keys to the stolen truck.

Harris was charged with the vehicle theft, possession of stolen property, exhibiting a deadly weapon, and resisting a peace officer.
