RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS SETTING THE RATES OF AND LEVYING COUNTY AND DISTRICT TAXES FOR THE 2023-24 FISCAL YEAR

WHEREAS, the property tax rates of the County of Solano for the 2023-2024 fiscal year shall be adopted by the Board of Supervisors of the County of Solano at its meeting on September 12, 2023; and

WHEREAS, Government Code section 29100 provides that the Board of Supervisors of a county shall set the rates for the secured tax roll in that county, in accordance with the provisions of that section and subject to the limitations specified in California Constitution Article XIII A and Revenue and Taxation Code sections 93 and 100.

RESOLVED, the Solano County Board of Supervisors fixes and levies the rates of the County taxes for the 2023-24 Fiscal Year follows:

At the rate of ONE DOLLAR (\$1.00) on each ONE HUNDRED DOLLARS (\$100.00) of full value in the County as shown in the files and records of the Solano County Auditor-Controller, which are incorporated by this reference, fixing the rates of County, Cities and District taxes for the 2023-24 Fiscal Year. The tax rate of ONE DOLLAR (\$1.00) on each ONE HUNDRED DOLLARS (\$100.00) of taxable full value shall be added additional sums of the voter-approved bonds, assessments, and indebtedness of the County of Solano, Cities, School Districts, Districts and Special Districts within the County of Solano as provided by law and as are set forth on the attached Exhibit 1, which is incorporated by this reference.
