Suisun Valley Strategic Plan Meeting Implementing the Solano County General Plan

SUISUN VALLEY 2ND STRATEGIC PLAN COMMUNITY WORKSHOP

You are invited to participate in the Second Community Workshop for the Suisun Valley Strategic Plan on June 29, 2009. The initial public meeting on January 20, 2009, provided an overview of the planning process that has been accomplished in the new General Plan and focus on developing the Suisun Valley Strategic Plan.

Since the first community meeting, there have been three stakeholders working sessions, in which key components of the Strategic Plan were reviewed and studied:

- Agricultural tourist center locations, scope and allowed uses
- Rural roadway character and design
- Zoning and development standards
- Infrastructure Alternatives
- Development fee program and improvement fund
- Marketing and branding strategy

The Second Community Workshop will provide an overview of the preferred alternatives for the various sections of the Strategic Plan. Comments and inputs received at the Community Workshop, along with

The new Solano County General Plan was adopted by Solano County Board of Supervisors on August 5, 2008 and came before the voters as Measure T on the November ballot. Measure T was passed by the voters, confirming the approval of the new general plan. One of the major elements of the new General Plan was the preservation of the County's agricultural resources and the implementation of regional agricultural strategic plans to specifically address agricultural issues for each area. Ten agricultural regions are identified: Suisun Valley, Green Valley, Dixon Ridge, Elmira/Maine Prairie, Jepson Prairie, Montezuma Hills, Pleasants/Vaca/Lagoon Valleys. Ryer Island, Western Hills and Winters.

recommendations prepared by American Farmland Trust, UC Davis' Solano County Agricultural Futures Project, and Suisun Valley Funds' Marketing Plan will be included in the strategic plan process. The workshop will build on these recommendations and findings to refine the concepts for the draft Suisun Valley Strategic Plan for the public review and approval.
