Applicable Code Sections:

3CCR 6000. Definitions: "Operator of the property" means a person who owns the property and/or is legally entitled to possess or use the property through terms of a lease, rental contract, trust, or other management arrangement.

3CCR 6420(a). Permit Requirements: Permits for the agricultural use of a restricted material shall be issued in the name of the operator of the property to be treated. The permittee or, when allowed by the commissioner, the permittee's authorized representative or licensed agricultural pest control advisor, shall sign the permit. The authorized representative or licensed agricultural pest control advisor shall provide the commissioner with written documentation from the permittee to act on his/her behalf.
