- Live in Solano County.
- Are available to participate in the luncheon on March 23, 2018.
- Have played an integral part in the development and/or implementation of project(s) or commerce that have benefited Solano County.
- Are not current Library employees, current elected officials or Solano County Library Foundation Board members.

Tips for completing the nomination form:

- Respond to all questions.
- Keep the selection criteria and this year’s theme in mind and address them when answering the questions.
- Keep answers short, concise, and clear.
- Tell the nominee’s story as if you were telling a stranger. The Selection Committee may not know the nominee.
- Please use the space provided for your answers.
