Subject: Significant Issues Update

1) County Administrator's update on contracts

The County Administrator signed the following contracts within her authority since the last Significant Issues memo, including:

The Department of Health and Social Services, Administrative Services division

- (1) A contract with BKD, LLP, to provide consulting services for Medi-Cal and Medi-Care cost reports and Medi-Cal PPS reconciliation, \$28,050, from July 1, 2018 to June 30, 2019. The funding source is Federally Qualified Health Center (FQHC) revenues.
- (2) A contract with Trilogy Integrated Resources, LLC, to provide ongoing maintenance for the Solano County Network of Care website, \$63,750, from July 1, 2018 to June 30, 2019. The funding source is a mixture of state and federal allocations.

The Department of Health and Social Services, Child Welfare Services division

- (1) A contract with California State University Fresno, Bay Area Academy, to provide training and coaching services to Child Welfare Services staff, \$50,064, from July 1,2018 to June 30, 2019. The funding sources are 58 percent Title IVE and 42 percent 1991 and 2011 Realignment funds.
- (2) A contract with Solano County Office of Education, to train teachers and students on human trafficking prevention, \$65,000, from August 1, 2018 to June 30, 2019. The funding source is state allocated money from the California Commercially and Sexually Exploited Children fund.
- (3) A contract with the Solano County Office of Education, to provide services to dependent youth residing in Solano County foster care, \$65,298, from July 1, 2018 to June 30, 2019. The funding source is 100 percent federally funded.
- (4) A contract with Youth for Change, to provide wraparound services, pursuant to SB163, to eligible adoptive families in Butte County, from September 5, 2018 to June 30, 2019. The funding source is 4 percent County General Fund and 96 percent 1991 and 2011 Realignment funds.

The Department of Health and Social Services, Employment and Eligibility Services

(1) A contract with Sefton Boyars, CPA, to review Health and Social Services contractor cost allocation plans, indirect cost rates, training and consultation, \$30,000, from July 1, 2018 to June 30, 2019. The funding source is allocated out of multiple state and federally funded programs.

The Department of Health and Social Services, Medical Services division

- (1) A contract with Mercury Pharmacy, to provide 340B prescription drugs to eligible participants of Solano County, \$49,900, from July 1, 2018 to June 30, 2019. The funding sources is Federally Qualified Health Center (FQHC) revenues.
- (2) A contract with Children's Choice Pediatric Dental Care, to provide anesthesia services to eligible Solano County children, \$60,000, from July 1, 2018 to June 30, 2019. The funding sources is Federally Qualified Health Center (FQHC) revenues.
- (3) A contract with John Jow, DDS, to provide dental services, primarily prosthetics, to residents of Solano County, \$74,861, from July 1, 2018 to June 30, 2019. The funding sources is Federally Qualified Health Center (FQHC) revenues.

The Department of Health and Social Services, Mental Health division

- (1) A contract with Monique Tarver, to provide the African American Faith-Based Initiative: Mental Health Friendly Communities, \$30,000, from July 1, 2018 to June 30, 2019. The funding source is Mental Health Service Act (MHSA) funding.
- (2) A contract with Gigi Crowder, to provide the African American Faith-Based Initiative: Mental Health Friendly Communities, \$40,000, from July 1, 2018 to June 30, 2019. The funding source is Mental Health Service Act (MHSA) funding.
- (3) A contact with First Choice in Psychiatric Recruitment, to recruit firms contracted to find appropriate professional staff as needed for hard to recruit positions, \$48,000, from July 1, 2018 to June 30, 2019. The funding sources are 44 percent County General Fund, 39 percent 2011 Realignment funds and 17 percent IGT funds.
- (4) A contract with Firdouse Huq, M.D., to provide psychiatric services, \$56,668, from July 1, 2018 to June 30, 2019. The funding sources is Federally Qualified Health Center (FQHC) revenues.
- (5) A contract with Xing Xing Luo, M.D., to provide psychiatric services, \$56,668, from July 1, 2018 to June 30, 2019. The funding sources are 51 percent federal funds, 20 percent County General Fund, 18 percent 2011 Realignment funds, 8 percent other payer and 3 percent IGT funds.

The Department of Health and Social Services, Public Health division

- (1) A contract with Sustainable Solano, to identify locations, build partnerships and install 4 community gardens as an implementation strategy of the Solano Community Health Improvement plan, \$50,000, from July 1, 2018 to June 30, 2019. The funding source is 1991 Realignment funds.
- (2) A contract with Bright Path Therapists, Inc., to provide supplemental therapy services to California Children Services Medical Therapy Program to meet state mandates, \$60,000, from July 1, 2018 to June 30, 2019. The funding source is the California Children's Services Medical Therapy Program.
- (3) A contract with Applied Survey Research, to conduct oral health community needs assessments and write oral health improvement plans for Solano County, \$74,132, from May 15, 2018 to June 30, 2019. The funding source is Prop 56 Oral Health funds.

The Department of Health and Social Services, Substance Abuse division

(1) A contract with Potentiate, LLC, to develop and coordinate the efforts of Solano County Health and Social Services, Behavioral Health Prop 47 implementation and grant related submission activities, \$60,000, from July 1, 2018 to June 30, 2019. The funding source is Prop 47 funds.

2) Update on continuity of Area Agency on Aging services

The California Department of Aging (CDA) has issued emergency contracts (beginning July 1, 2018 through December 31, 2018) with providers in Planning Service Area (PSA) 28 (Napa and Solano Counties) to ensure continuity of Area Agency on Aging services. On October 2, 2018, the CDA notified Solano County that NorthBay Health Care and NorthBay Health Advantage declined to enter an emergency contract to provide previously delivered and expanded services in Solano County. These services, requested for the period July 1 through December 31, 2018; are in the Family Caregiver Support (FCSP) IIIE - Supplemental Services, Access Assistance, Support Services and Respite Care services funding categories.

Because the funds were declined, CDA notified Solano County that \$68,327 is available to be used (for the period September 2018 through December 2018) for provision of services in several areas, including FCSP Community Education, Support Groups and Counseling, Respite, Information Services, Supplemental Services, Access Assistance and Support Services. The CDA will amend its contract with Solano County to include the additional funding and Solano County staff are actively seeking solutions to distribute these newly identified available funds.
