EVICTION PROTECTIONS

In addition to Governor Newsom's Executive Order, the California Judicial Council (the entity that oversees the courts in California) has issued new rules. The new rules state that the courts cannot grant an eviction unless it is necessary for the public health and safety. The order is effective for until 90 days after the Governor lifts the state of emergency related to Covid-19.

The Solano Sheriff also has said he will not enforce evictions during the crisis. The county continues to monitor the eviction protections in place and is in discussion with tenant advocates to provide expanded protection. I also sent a letter to the Governor asking him to revise his executive order or issue a new one to provide stronger tenant protections.

STATEMENT FROM THE DISTRICT ATTORNEY

Here is a statement from Solano County District Attorney Krishna Abrams on what is available through her office during this time:

"During this global health crisis, it has proven to be a very unsettling time for all us. On March 19, 2020, Governor Newsom issued a "Shelter in Home" Executive Order to all Californians. It is important that each one of us abide by the health directives and executive order of the Governor, specifically to take all precautionary measures to help mitigate the spread of COVID-19 (Coronavirus). Please continue to wash your hands, engage in social distancing (stay within 6 feet of others), and avoid others who may be ill.

We want you to know that although there is an emergency order in place reducing court operations during this difficult time, the District Attorney's Office remains open for questions or concerns you may have regarding court cases or crime in our community. We are diligently working with the Court and our criminal justice partners to help mitigate the spread of this disease, while also seeking to protect the safety of our community. If you are a witness in a case, victim of crime, or just have questions regarding a case, please do not hesitate to call our office at 707-784-6800 or email <u>solanoda@solanocounty.com</u> with any of your inquiries. For immediate assistance, please contact the Officer of the Day at 707-784-3188. We are here to answer any questions you may have and to assist you during this time.
