PHASED REOPENING AND FACE COVERINGS	Resource Management
The county is proceeding with reopening businesses in accordance with the level of risk and in accordance with the state guidelines. The Governor issued new guidelines this week regarding reopening certain businesses. However, the Public Health Officer did state that we would require face A coverings for the higher risk businesses. The county public health department is also strongly encouraging people to wear face coverings when conducting essential business.

County Counsel did say there was a possibility that individual cities could adopt a face covering requirement. I sent letters to the Mayors of Benicia, Fairfield and Vallejo asking them to implement a mask requirement in their respective cities.

The county is still in the process of planning how to regulate businesses for health and safety during this time. This is a constantly evolving situation and we are receiving new information from the State regularly. I will do my best to share information as I receive it.

For me personally, I will not be going out except for essential activities until this crisis is over. I will go to work, to the store, to the credit union, to get food and to the auto shop if need be. Regardless of what businesses are permitted to open, I will do my best to limit my time outside. And when I am at an essential business, I will be wearing my mask. I encourage everyone else to wear a mask as well when you are at an essential business.

### ADDITIONAL FOOD BENEFITS FOR CHILDREN AND FAMILIES

I want to thank California Superintendent of Education Tony Thurmond for his work to help families struggling with food insecurity during this time. The California Department of Education has announced additional resources for families and students needing food during this difficult time. You may be eligible for the Pandemic Electronic Benefit Transfer (P-EBT).

The P-EBT will provide electronic food benefits to families equal to the value of free or reduced priced meals they would have received at school. Families with eligible students can receive up to \$365 per eligible child. P-EBT card were sent out in early May.

Even if you're child was not previously eligible for free or reduced lunches, your circumstances may have changed to where you are now eligible. The deadline to apply is June 30, 2020. Please see this link for more information:

### VOTING DUIRNG THE CORONAVIRUS CRISIS

Governor Newsom signed an executive order requiring that all registered voters in California will be mailed ballots they can return by mail. There will also be voting centers where voters will be able to drop off their ballots or obtain new ballots to vote in person or replace lost or spoiled ballots.

The state and the county want to provide voters with as much flexibility to vote while also ensuring the safety of our residents. The return envelopes will contain prepaid postage, meaning the voter will not have to pay to mail the envelope.
