SOLANO COUNTY BOARD OF SUPERVISORS

The Solano County Board of Supervisors met on the 13th day of September, 2005 in regular session in the Chambers of the Board of Supervisors of the County of Solano in the Solano County Government Center, 675 Texas Street, Fairfield, California at 8:33 a.m. pursuant to County Code Seciton 2-1.103. Present were Supervisors Kromm, Reagan, Silva, and Vice-Chair Vasquez. Also present were Michael D. Johnson, County Administrator and Wendy Getty, Assistant County Counsel. Chairwoman Kondylis arrived at 8:35 a.m.

Closed Session

The Board of Supervisors recessed this meeting at 8:33 a.m. to convene in Closed Session on the following matters:

RECONVENE

The Board of Supervisors reconvened in Open Session at 9:20 a.m. All members were present. Chairwoman Kondylis presided.

SALUTE TO THE FLAG AND A MOMENT OF SILENCE

The meeting continued with the Pledge of Allegiance to the Flag and a moment of silence.

REPORT OF ACTION IN CLOSED SESSION

Assistant County Counsel Wendy Getty noted that there were no reports from Closed Session.

Agenda Item No. 2

Presentation

The Board of Supervisors presented a Proclamation recognizing September as Disaster Preparedness Month.

Supervisor Reagan stressed the importance of preparing for emergencies and encouraged individuals to take action because no community is truly prepared for a disaster until every individual, family and business takes personal responsibility for preparedness.

Bob Powell, Director of Solano County Office of Emergency Services, noted that emergency preparedness begins at home and the importance to have the capability of sustaining oneself for 72 hours to five days. Mr. Powell reported that resources are coordinated between the Red Cross, Salvation Army, and other agencies to produce cots for bedding and shelter on a regional basis and efforts have been coordinated with Anheuser Busch and other business to produce clean water. Mr. Powell stated that the Office of Emergency Services, Sheriff's Office, and all agencies have dedicated themselves to enhance their capabilities and that their most recent accomplishment has been the opening of a new emergency operation center which will increase their operational capacity. It was noted that the Disaster Council meets on a quarterly basis to prepare for disasters and to make sure that there is radio operability in the County.

- B) Donald Tipton, unincorporated Vallejo, expressed concerns regarding parking at the County Government Center and requested assistance in addressing noise violations in the unincorporated area of Vallejo.
- C) Chairwoman Kondylis requested that this meeting of the Board of Supervisors be adjourned in memory of Deonn Baker.
- D) Chairwoman Kondylis announced the implementation of a Countywide toll free information line by dialing 866-776-5266 (866-7SOLANO).
- E) Steven Kays addressed the Board regarding the need for economic development in Solano County and the need for higher paying jobs for the residents in order to alleviate traffic congestion and decrease criminal activity.
