MINUTES

The Solano County Board of Supervisors met on the 11th day of October, 2005 in regular session in the Chambers of the Board of Supervisors of the County of Solano in the Solano County Administrative Center, 675 Texas Street, Fairfield, California at 8:32 A.M. pursuant to County Code Section 2-1.103. Present were Supervisors Kromm, Reagan, Silva, and Vice-Chair Vasquez. Chairwoman Kondylis was excused. Vice-Chair Vasquez presided. Also present were Michael D. Johnson, County Administrator and Wendy Getty, Assistant County Counsel.

Agenda Item No. 1 Closed Session

The Board of Supervisors recessed this meeting at 8:33 a.m. to convene in Closed Session on the following matters:

Open Session

The Board of Supervisors reconvened in Open Session at 9:00 a.m. Present were Supervisors Kromm, Reagan, Silva and Vice-Chair Vasquez. Chairwoman Kondylis was excused. Vice-Chair Vasquez presided.

Report of Action in Closed Session

Assistant County Counsel Wendy Getty noted that there were no reports from Closed Session.

The meeting continued with the Pledge of Allegiance to the Flag and a Moment of Silence.

Items From the Public

Vice-Chair Vasquez invited individuals of the public to make statements on matters relating to the business of the Solano County Board of Supervisors. The following individuals made public comments:

A. Donald Tipton, unincorporated Vallejo, expressed his concern regarding Solano County's preparedness in the event of a disaster. Mr. Tipton also noted that Caltrans will be removing 800 eucalyptus trees along the I-80 and 680 corridor and inquired if Solano County had been notified.

C. Supervisor Kromm requested that this meeting of the Board of Supervisors be adjourned in memory of Leola Smallwood.

D. Supervisor Kromm noted that Longs Drug Store in Fairfield has volunteered to require customers to purchase medication containing pseudoephedrine from the pharmacist.

E. Vice-Chair Vasquez requested that this meeting of the Board of Supervisors be adjourned in memory of Martha "Marty" Van Westerhuyzen.

2. Approved the Board of Supervisors' minutes and the Rural North Vacaville Water District minutes of October 4, 2005.

3. Approved proclamations honoring the American Legion 2005 Boys State recipients: Jake Martinson, Vacaville High School; Frank Parish, Vanden High School; Aaron Crawford, Will C. Wood High School; and the American Legion Auxiliary 2005 Girls State recipients: Kathryn Jackson, Vacaville High School; Heather Blair, Vanden High School; Ruby Tamariz, Will C. Wood High School.

4. Approved the Uniform Allowance Side Letter Agreement with SEIU, Local #1280, representing Unit #12 Probation Employees.

5. Adopted and authorized Vice-Chair Vasquez to sign Resolution No. 2005-214 approving the filing of an application for grant funds from the California River Parkways Grant Program under the Water Security, Clean Drinking Water, Coastal and Beach Protection Act of 2002 (Proposition 50) for the Lake Solano Regional Park Project portion of the Putah Creek Parkway. The estimated amount of the grant application will not exceed \$2,400,000. (see Resolution Book)

6. Adopted and authorized Vice-Chair Vasquez to sign Resolution No. 2005-215 authorizing Jearl Howard, Solano County Agricultural Commissioner/Sealer of Weights and Measures, to sign specified annual renewal agreements to State contracts with California Department of Food and Agriculture and the California Department of Pesticide Regulation and to execute any amendments to these agreements for FY2005/2006 on behalf of Solano County. (see Resolution Book)

7. Approved and authorized Vice-Chair Vasquez to sign a Declaration of Intent to Apply for Emergency Medical Services Appropriation (EMSA) funding. Approved an Appropriation Transfer Request to recognize unanticipated revenue in the amount of \$20,877 and to distribute the expenditures.

8. Approved a master contract between the County of Solano and Emani House for the period of November 1, 2005 through June 30, 2006 for substance abuse services under the 2000 Substance

Abuse and Crime Prevention Act Program (SACPA – a.k.a. Prop 36) and for drug testing services. Authorized the Chief Probation Officer/Director of Probation to execute any additional master contracts with new service providers to fill underserved geographic locations or program population. The master contract term may not exceed June 30, 2006.

9. Approved an Appropriation Transfer Request (ATR) of \$79,700 in unanticipated revenue from the U.S. Department of Justice to support the Family Violence Response Team in the Probation Department.

Agenda Item No. 11 County's Strategic Plan and 3-Year Goals/ Presentation of Drug Awareness Program/ Public Affairs Officer Position

Took the following action:

A. Received a Status Report on the County's Strategic Plan and Three Year Goals and Objectives. Directed staff to modify language relative to birth outcomes to make clear and direct.

B. Received a presentation from the Public Defender concerning implementation of the Drug Awareness Program.

C. Adopted and authorized Vice-Chair Vasquez to sign Resolution No. 2005-216 amending the Alphabetical Listing of Classes and Salaries to reflect the addition of a Public Affairs Officer position (Senior Management, At-Will and exempt from Civil Service) with an approximate annual top step of \$86,804. (see Resolution Book)

D. Adopted and authorized Vice-Chair Vasquez to sign Resolution No. 2005-217 amending the List of Numbers and Classifications of Positions to add 1.0 FTE Public Affairs Officer position to the County Administrator's Office. (see Resolution Book)

E. Directed staff to modify the position title of Public Affairs Officer, if necessary.

Item No. 10 Legislative Advocate

Received a presentation from Solano County's Legislative Advocate and adopted the County's 2006 State Legislative Platform which included Legislative Priorities – Level One to include 1) Separation of Local Trial Courts; 2) Defense of Incarcerated Inmates in State Prisons; 3) Proposition 36 Funding and Implementation; 4) Social Services Overpayment Errors; 5) Vote Centers; 6) Housing Reform; 7) Levee Maintenance; and 8) Medi-Cal Program Funding; and Level Two Priority Items relating to: 1) improving the lives of children and their families; 2) improving the health and well being of those who live and work here; 3) maintaining a safe community; 4) promoting agriculture and supporting responsible land use and economic development; 5) investing resources in and for the future; and 6) long term objectives.

Agenda Item No. 17 Three-Year Plan for Prevention of Child Abuse and Neglect

Approved a three-year plan for Promoting Safe and Stable Families (PSSF), Child Abuse Prevention Intervention Treatment (CAPIT), Community Based Child Abuse Prevention (CBCAP) and Children's Trust Fund (CTF) programs, for the three-year funding cycle starting in FY 2005/06 providing \$620,036 for the prevention of child abuse and neglect.

Vice-Chair Vasquez reopened the public hearing which was held on September 27, 2005 to allow public comment on the Solano County Housing Element.

Robert Stalker, Legal Services of Northern California, noted that there was a crisis of affordable housing in Solano County and requested that the County do more in the Housing Element to provide opportunity for the most vulnerable in the community.

At the conclusion of the public hearing, the Board took the following action:

A. Ratified the action taken on September 27, 2005 to approve the Negative Declaration, vacated that approval, and approved the Negative Declaration.

B. Ratified the action taken on September 27, 2005 to approve the Solano County Housing Element, vacated that approval, and approved the Solano County Housing Element.

Agenda Item No. 20 Wood Burning Ordinance

Acted to read the proposed ordinance adding Chapter 6.6 relating to wood burning appliances in the unincorporated area to the Solano County Code.
