MINUTES

The Solano County Board of Supervisors met on the 6th day of December, 2005 in regular session in the Chambers of the Board of Supervisors of the County of Solano in the Solano County Administrative Center, 675 Texas Street, Fairfield, California at 8:33 A.M. pursuant to County Code Section 2-1.103. Present were Supervisors Kromm, Reagan, Silva, and Chairwoman Kondylis. Supervisor Vasquez arrived at 8:34 A.M. Also present were Michael D. Johnson, County Administrator and Dennis Bunting, County Counsel.

Agenda Item No. 1 Closed Session

The Board of Supervisors recessed this meeting at 8:34 a.m. to convene in Closed Session on the following matters:

Open Session

The Board of Supervisors reconvened in Open Session at 9:15 a.m. All members were present. Chairwoman Kondylis presided.

Report of Action in Closed Session

County Counsel Dennis Bunting noted that the Board, by unanimous vote, decided not to initiate litigation as requested by Mr. Bernard Moore and directed the County Counsel to prepare a letter to Mr. Moore for the Chairwoman's signature outlining the reasons for this action.

Salute to the Flag and Moment of Silence

The meeting continued with the Pledge of Allegiance to the Flag and a Moment of Silence.

Agenda Item No. 2 Presentations

The Board of Supervisors received the following presentations:

- A. Presentation by Mary Bourguignon, campaign manager for the Book by Book fundraising campaign to help pay for the opening day collection of books and materials for the Fairfield Cordelia Library. The Board of Supervisors agreed to recognize any donor who makes a donation of \$10,000 or more with a Certificate of Appreciation.
- B. Accepted a report regarding the 2005 North Bay Stand Down and approved support for the 2006 North Bay Stand Down for Veterans.

Items From the Public

The Chairwoman invited individuals of the public to make statements on matters relating to the business of the Solano County Board of Supervisors. The following individuals made public comments:

- A. Donald Tipton, unincorporated Vallejo, expressed his concern regarding annexation of pockets of unincorporated areas into the surrounding cities and felt that the residents of these pocket areas should be notified and included in the discussions. Mr. Tipton noted that there was an agreement between the County and Cable Television to provide regular viewing of the Board of Supervisors' meetings and did not feel that the Cable Television Company in Vallejo was providing this service. Mr. Tipton noted that he felt that there should be fees collected for people using the ATM machine located at the County Government Center.
- B. County Administrator Michael D. Johnson noted that the County informational brochure update has been completed and were available for the public.
- C. Supervisor Reagan complimented the Sheriff's Department and Health and Social Services for conducting a table top exercise addressing the Avian Flu and other possible biological outbreaks on January 18, 2006.
- D. Supervisor Kromm requested that this meeting of the Board of Supervisors be adjourned in memory of Evelyn May Parker Williams.
- E. Supervisor Vasquez requested that this meeting of the Board of Supervisors be adjourned in memory of Brice Bledsoe, Jr., longtime Manager of the Solano Irrigation District.

Directed that the salary schedule be reviewed with comparable counties for those classifications where there are a large number of employees. Directed that discussion regarding compensation methodology and compensation policies for executive management be brought back to the Board of Supervisors in January, 2006 to allow time for the Board to review the information provided by the consultant and the Subcommittee.

The Board continued the public hearing from November 1, 2005 to consider approval of Minor Subdivision Application No. MS-05-02 of Craig McNamara to subdivide a 325 acre parcel into three parcels of 41 acres, 144 acres, and 138 acres respectively and to adopt a resolution approving Minor Subdivision Application MS-05-02. The property is located at 5193 Putah Creek Road in an "A-40" Exclusive Agricultural Zoning District.

At the conclusion of a public hearing to consider the acquisition of real property and improvements located at 600 Kentucky Street, Fairfield (Assessor's Parcel Numbers 0030-151-130 and 0030-161-030) from the City of Fairfield, the Board took the following action:

- A. Adopted and authorized Chairwoman Kondylis to sign Resolution No. 2005-245 authorizing the purchase of the real property which includes: (see Resolution Book)
- 1. Authorization for the County Administrator to execute a Purchase and Sale Agreement with the City of Fairfield to acquire the real property for the cash sum of \$1,800,000 plus estimated closing costs of \$15,000 for a total not to exceed \$1,815,000.

- B. Approved the following appropriation transfers for a total of \$620,000 to the ACO project budget #1726 to pay for the acquisition of the property:

- 2. \$120,000 in unanticipated lease revenues from the Post Office.
- 3. \$300,000 as a loan from the General Fund to the ACO Fund.
