VOTING

Ballots have already been sent out in Solano County. I have heard from many of my constituents that the state voter guide (SVG) has not been received. The SVG contains an impartial analysis as well as arguments in favor and arguments against the state ballot propositions.

I sent a letter to Secretary of State Alex Padilla asking him to send the SVG ASAP. The county was told the SVG would be mailed to Solano County voters this weekend. That means it should arrive next week. The SVG is available online. To find it, please go

As far as voting goes, you will have several options. If you chose to use the ballot that was mailed to you, you may: (1) Fill it out and mail it to the registrar (postage is covered by the county). (2) You may drop it off at one of the designated ballot drop off locations (starting October 5), (3) You may drive to a curbside drop off location and hand it to one of the election workers without leaving your car (starting October 29th and going through election day), (4) You may drive to a polling place on election day

and either (a) drop off your ballot curbside without getting out of your car or (b) drop it off inside the polling place.

Should you chose to use the ballot that was mailed to you, please remember that it must be postmarked by Nov. 3rd and received by the registrar no later than Nov. 20th. To ensure that it is postmarked on by Nov. 3rd. I would recommend you get the ballot in the mail no later than Nov. 2nd.

Should you choose to vote in person and not use the ballot that was mailed to you, you may vote in person either through early voting (starting October 5th) at the registrar's office or you may vote in person at your assigned polling place on election day (Nov. 3). If you chose to vote in person without using the ballot that was mailed to you, please bring your mail-in ballot to surrender. If you do not bring your mail-in ballot to surrender, you may have to vote via a provisional ballot. Provisional ballots will only be counted once it is confirmed that the voter is eligible to vote and the voter has not already voted in the election.

Specifically, for Benicia, a ballot drop off location was added at the Raley's in Southampton. I wanted to point this out because this location was chosen after the county voter guide was prepared so Raley's is not listed in the guide that was mailed out.
