Hello Benicia, Fairfield, and Vallejo,

As I said in my last update, I know our community is anxious to get the vaccine. Unfortunately, the hard truth is that there are simply not enough vaccines currently to vaccinate everyone who is eligible. It is predicted that by summer we should be able to offer vaccines to the general public. Until we are vaccinating the general population, we will work off the tier system from the state.

Most vaccines are being sent directly to healthcare providers. 2/3 of Solano County residents are Kaiser Permanente members. Kaiser received most of the vaccines for Solano County. Currently, most people eligible to receive a vaccine will receive their vaccine through their healthcare provider.

I understand how difficult is for all of us. The vaccine will help us get back to normal, which we are all anxious to do. The reality is that we do not have enough vaccines as of right now. We will get there, but it will take some time.

President Biden has announced his Covid-19 plan (link provided below). One of the actions the President took is to issue an executive order invoking the Defense Production Act. This will allow the government to use private industries to produce necessary supplies.

The county's vaccine townhall that was held today should be posted on the county's coronavirus webpage next week to view.
