#### 1. Roll Call/Call to Order

Chair Lori Wilson called the meeting to order at 6:00 P.M. Present were the Mayor of Benicia Steve Young, Mayor of Fairfield Harry T. Price, Mayor of Rio Vista Ron Kott, Mayor of Suisun City Lori Wilson, Mayor of Dixon Steve Bird; Mayor of Vallejo Robert McConnell (6:02 p.m.) and Mayor of Vacaville Ron Rowlett (6:18 p.m.)

#### 2. Public Comment

There were no members of the public present on the Zoom Meeting call.

At 6:02 p.m. Mayor Robert McConnell is now in attendance.

#### 3. Business:

A. Approve the Minutes of the December 16, 2020 City Selection Committee meeting.

On motion of Mayor Kott, and seconded by Mayor Price, the Committee acted to approve the minutes of the December 16, 2020 meeting. So ordered by 5-0 vote with Mayor Young abstaining and Mayor Ron Rowlett absent.

B. Appoint one (1) Mayor to serve as primary representative and one Mayor to serve as alternate representative to the Association of Bay Area Governments Executive Board for term ending June 30, 2023.

Chair Wilson stated she would like to extend her term for one additional year; however, she will be unable to serve the second year of the term. Chair Wilson requested the committee approve her reappointment, and direct staff to fill the remainder of the term in June 2022.

On motion of Chair Wilson, and seconded by Mayor Price, the Committee acted to appoint Mayor Wilson as primary representative and Mayor Young to serve as alternate representative to the Association of Bay Area Governments Executive Board for term ending June 30, 2023. So ordered by 6-0 vote with Mayor Ron Rowlett absent

C. Appoint one (1) Mayor as primary member and one (1) Mayor as alternate member to the Solano Consolidated Oversight Board for a term ending June 30, 2022.

On motion of Mayor Kott, and seconded by Mayor Price, the Committee acted to appoint Mayor Wilson as primary representative and Mayor Kott, as alternate member to the Solano Consolidated Oversight Board for a term ending June 30, 2022. So ordered by 6-0 vote with Mayor Ron Rowlett absent

**4.** Discussion and review of other appointments as needed.

Chair Wilson stated she was elected as Second Vice President on the North Bay Division of the League of California Cities Executive Committee, leaving the City Selection Committee appointment vacant. She noted this committee is not only for Mayors and recommended the City Selection Committee consider appointing a City Council member instead.

Discussion was held with the Committee deciding to select three individuals, prioritizing them in order from 1-3 and appoint in order of declination from 1-3: 1) Dixon Vice Mayor Jim Ernest; 2) Fairfield City Council Member Doriss Panduro; and 3) City of Suisun City Mayor Pro Tem Wanda Williams.

At 6:18 p.m. Mayor Ron Rowlett is now in attendance.

On motion of Mayor Wilson, seconded by Mayor McConnell, the Committee selected the following individuals for consideration to be the representative to the League of California Cities Executive Committee: 1) Dixon Vice Mayor Jim Ernest; 2) Fairfield City Council Member Doriss Panduro; and 3) City of Suisun City Mayor Pro Tem Wanda Williams with an appointment in order of declination from 1-3. So ordered by 7-0 vote.

RE: Solano County Selection Committee Appointment to the Airport Land Use Commission

Dear Mayor Wilson,

It has recently come to my attention that Ruth Meyer, a valuable member of the Airport Land Use Commission since 2015, has lost her position as the District 5 Supervisorial representative due to a misunderstanding when the new supervisor took office and filled what he thought was a "vacant" position.

I would like to recommend the Solano County Selection Committee consider appointing Ruth to fill the vacancy of the Vallejo representative at its June 16<sup>th</sup> meeting. It has historically been difficult for Vallejo to find a person willing and qualified to serve on this important, technically demanding commission. Ruth Meyer is an outstanding choice. She is a retired Air Force Colonel, and a pilot by profession. As a reservist stationed at Travis AFB during most of the last 20 years, she is very familiar with Solano County, its airports and land use regulations, and an active contributor to the community – serves as a Board of Director for the Leaven as an example. Her pilot and leadership expertise are a major asset to the Airport Land Use Commission, and the commission would like to find a way to retain her.

The Board of Supervisor appointments to this commission are no longer based on residing within the district because there was recognition by Board members of the need to place the priority on the qualifications of the candidate. This is also true for the Mayor's representatives – they are not required to reside in the City, only in the County.

I'm hoping all the Mayors will see appointing Ruth Meyer as a win-win – the Airport Land use Commission will be able to retain a valuable, experienced commissioner and the Mayors Selection Committee will have a highly qualified person to appoint to this hard-to-fill position who is interested in continuing to serve on it.

I would also like to suggest that we try one more time to amend the County Ordinance to reflect a representative from Suisun City rather than Vallejo, due to its location adjacent to Travis Air Force Base, and bring clarity to the benefit of this.

Dear Mayor Wilson,

On behalf of the Solano County Airport Land Use Commission (ALUC), I would like to forward the name of Ruth Meyer for your consideration to fill the Mayor's vacancy on the commission. Ruth was appointed to the ALUC on November 24, 2015, and has been a very valued member of the commission ever since. We were saddened to learn that through no fault of hers, Ruth lost her spot on the commission. Her term had lapsed under the outgoing District 5 supervisor, so the incoming supervisor appointed a representative to fill an official vacancy.

Ruth Meyer is eminently qualified to serve on this technically demanding commission. She is a pilot by profession, has a master's degree in Aerospace Technology, and is a retired Air Force Colonel who served at Travis AFB during most of the last 20 years. She is very familiar with Solano County, its airports and land use regulations – factors that make her such a good fit for the ALUC and hard to replace.

We highly recommend the Solano County Selection Committee consider appointing her to fill the vacancy of the Vallejo representative at its June 16<sup>th</sup> meeting. It is our understanding that It has been difficult to find a Vallejo resident willing and qualified to serve on our commission. We ask you to waive the "Vallejo area" preference since Ruth is a resident of Vacaville. Our legal counsel indicates the Mayors appointees are not required to live in the City, only in the County.

In conclusion, I, and all of my fellow commissioners, earnestly request your help in getting Ruth Meyer reappointed to our commission.
