### BACKGROUND:

As discussed during the January meeting, in an effort to assure continuity and consistency in agency operations, a decision was made to recreate the EMS Administrator classification, which is responsible for oversight of the EMS Agency and activities but is no longer the primary individual responsible for management of other public health programs such as Immunizations and Communicable Disease Control. The EMS Administrator continues to serve as the Medical Health Operational AreaCoordinator (MHOAC) and primary point of contact for the EMS Program.

• Provide update and consider funding for countywide rollout of Emergency Medical Dispatch and Pre-Arrival Instruction

#### BACKGROUND:

For over two years the EMS Agency, Fire Departments, Dispatch Centers, Ambulance Providers, Hospitals, and Law Enforcement Agencies have been working together to establish an agreed upon system for provision of Emergency Medical Dispatch (EMD) and Pre-Arrival Instruction (PAI) for 9-1-1 callers. There was consensus that this life-saving service be implemented county wide in Solano. This comes at a cost of approximately \$330,000. Agency staff have been working diligently to identify funds to procure the necessary software and training to make the rollout of EMD/PAI a reality.

The mission of the Cooperative and Agency is to provide high-quality emergency medical care and treatment to Solano County residents and visitors. It is imperative that EMD/PAI be rolled out as soon as possible, as Solano is one of the few jurisdictions that does not provide PAI to 9-1-1 callers. Implementation of this service will improve medical outcomes and will undoubtedly result in saved lives.

It is recommended that Staff be directed to explore the feasibility of using existing Maddy Fund account proceeds to acquire the necessary software, training, etc. to implement EMD/PAI in each of the participating Primary Service Answering Points (PSAP) Call Centers, or 9-1-1 Dispatch Centers, falling within the jurisdictional boundaries of the Cooperative. California Vehicle Code violation proceeds create Maddy Funds which are intended to support provision of emergency medical treatment to the underserved, with a focus on improving pediatric trauma capabilities. The requirements associated with Maddy Fund disbursement and management are outlined in California Health and Safety Code (HSC) Sections 1797.98a, et seq.

It is further recommended that Staff be directed to explore alternative funding options in the event Maddy Funds are insufficient to cover the entire costs of this project. As a fall back, it is recommended that your Board vote to approve the use of SEMSC reserves to fund this critical endeavor as a contingency if all other funding streams do not provide the necessary monies to roll-out the system countywide.
