**RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS
APPROVING TRAFFIC ORDER 428, ESTABLISHING AN ALL-WAY STOP AT THE
INTERSECTION OF WINTERS ROAD AND PUTAH CREEK ROAD**

WHEREAS, Chapter 17 of the Solano County Code sets forth the requirements for the establishment of traffic orders; and

WHEREAS, an Engineering and Traffic Study has confirmed that the intersection of Winters Road and Putah Creek Road 0.3 miles south and west of Winters Bridge warrants an all-way stop; and

WHEREAS, based on said surveys and conforming to accepted principles and practices of traffic engineering, the Director of Resource Management has made Traffic Order 428 to establish an all-way stop at the intersection Winters Road and Putah Creek Road; and

WHEREAS, said traffic order does not become effective until it has been adopted by resolution by the Board of Supervisors.

RESOLVED, Traffic Order 428 is adopted establishing an all-way stop at the intersection of Winters Road and Putah Creek Road pursuant to the provisions of Chapter 17 of the Solano County Code.


RESOLVED, the Director of Transportation is directed to place appropriate signs and markings at the affected intersections.
