DRAFT MINUTES

1. Roll Call/Call to Order

Chair Robert McConnell called the meeting to order at 6:00 P.M. Present were the Mayor of Benicia Steve Young, Mayor of Fairfield Harry T. Price, Mayor of Dixon Steve Bird, Mayor Pro Tem of Suisun City Alma Hernandez, Mayor of Rio Vista Ron Kott and Mayor of Vallejo Robert McConnell. Absent: Mayor of Vacaville Ron Rowlett.

2. Public Comment

There were no members of the public present on the Zoom Meeting call.

3. Business:

A. Approve the Minutes of the September 15, 2022 City Selection Committee meeting.

On motion of Chair McConnell and seconded by Mayor Kott the Committee acted to approve the minutes of the September 15, 2022 meeting. So ordered by a 6-0 vote with Mayor Rowlett absent.

B. Appoint two (2) Mayors to the Local Agency Formation Commission (LAFCO) to fill current terms of two (2) primary representatives set to expire on May 4, 2026

Chair McConnell called for nominations.

Mayor Price nominated Mayor Bird and Mayor Kott as primary representatives to serve terms through May 4, 2026.

Secretary Alicia Draves stated with the nomination of Mayor Kott as primary representative, the Committee will also need to accept nominations for a new alternate representative.

Mayor Pro Tem Hernandez nominated herself to serve as alternate for the remainder of Mayor Kott's term through May 1, 2023.

On motion of Mayor Price and seconded by Mayor Bird the Committee acted to appoint Mayor Bird and Mayor Kott as primary representatives for terms through May 4, 2026 and Mayor Pro Tem Alma Hernandez as alternate representative for a term through May 1, 2023. So ordered by a 6-0 vote with Mayor Rowlett absent.

C. Approve the submittal of a letter of support for the continuance of term for Supervisor Jim Spering to the Metropolitan Transportation Commission (MTC) for a term through February 9, 2023

Mayor Bird spoke in support of the submittal of a letter of support for the continuance of term for Jim Spering to the Metropolitan Transportation Commission (MTC) for a term through February 9, 2023.

Mayor Young spoke in support of appointing Jim Spering past the February 9, 2023 term date.

In response to a question from Mayor Young regarding Jim Spering serving beyond the February 9, 2023 end of term, Secretary Draves stated pursuant to California Government Code section 66504, the City Selection Committee is required to submit a request to the Board of Supervisors to allow Jim Spering to stay on to fulfill the remainder of his term on the Metropolitan Transportation Commission beyond the expiration of his term on the Solano County Board of Supervisors. Secretary Draves further stated the next item on agenda will allow the Committee to submit Jim Spering's name with two additional names for the February 10, 2023 though February 9, 2027 term.

On motion of Chair McConnell and seconded by Mayor Bird the Committee acted to approve the submittal of a letter of support for the continuance of term for Supervisor Jim Spering to the Metropolitan Transportation Commission (MTC) for a term through February 9, 2023. So ordered by a 6-0 vote with Mayor Rowlett absent.

D. Nomination to the Solano County Board of Supervisors for appointment of one (1) representative to the Metropolitan Transportation Commission (MTC) for a 4-year term to expire February 9, 2027 (3 nominations required to be submitted to the Board of Supervisors)

From Chair McConnell: Jim Spering

Secretary Alicia Draves stated the Committee would submit a nomination for three individuals to the Board of Supervisors one of which could be Jim Spering. Secretary Draves further stated if the Board chooses to appoint Jim Spering for the term, if or when Jim Spering submits his resignation, the Clerk would then put the nomination of 3 more individuals back on the City Selection Committee agenda to allow for the Committee to submit three new names to the Board of Supervisors for appointment MTC, noting this would be for the remainder of the existing term.

In response to a question from Mayor Young regarding if the MTC appointment is required to be held by an elected official, Secretary Draves stated there is no requirement for this position to be held by an elected official.

On motion of Mayor Young and seconded by Mayor Kott the Committee acted to approve the nomination of Jim Spering, Mitch Mashburn and Monica Brown for the appointment to the MTC. So ordered by a 6-0 vote with Mayor Rowlett absent.

E. Appoint one (1) Mayor to the Remote Access Network (RAN) Board for a 1-year term to expire on December 31, 2024.

On motion of Mayor Bird, and seconded by Mayor Price, the Committee acted to appoint Mayor McConnell to serve as representative on the Remote Access Network (RAN) Board for the term of January 1, 2023 to December 31, 2023. So ordered by a 6-0 vote with Mayor Rowlett absent.

F. Selection of Chair and Vice-Chair for 2023

On motion of Mayor Kott and seconded by Mayor Price, the Committee acted to appoint Mayor Bird as the Chair and Mayor Young as the Vice-Chair of the Solano County City Selection Committee for the 2023 calendar year. So ordered by a 6-0 vote with Mayor Rowlett absent.
