### **March 5, 2024 Presidential Primary Election Certified Results from the Solano County Registrar of Voters**

The Solano County Registrar of Voters (ROV) has prepared a certified statement of the results of the March 5, 2024 Presidential Primary Election.

#### **HIGHLIGHTS OF THE PRIMARY ELECTION**

- 266,751 – number of ballots Issued to all voters in the affected area
- 44,954 – number of ballots returned by mail
- 34,185 – number of ballots returned at drop off locations around the county
- 12,675 – number of ballots CAST in-person at election day polling places
- 34.42% percent – overall registered voter turnout

In-person voting continues to stay relatively low with an average of 13% of the turnout attributed to voters voting ballots at 70 polling locations. The ROV did not experience any reports of voters waiting to vote at polling places and will continue to monitor this for higher turnout elections. The average number of voters per location was 78 for the Primary Election.

#### **ENSURING ACCURACY OF RESULTS**

As part of canvassing the results, a minimum 1% hand count of voted ballots is required by California Election Code §15360. The ROV performed an audit which included a random hand count of 2.24% percent of the valid ballots, comparing the totals to the electronic results submitted to ensure accuracy. The audit included a complete hand count of the Board of Supervisors District 1 contest (14,976 ballots or 16.31% of all ballots cast).
