Dear Chairwoman Durazo,

On behalf of the Solano County Board of Supervisors, I write in support of SB 239, which would allow committees, commissions, and Boards to hold meetings virtually under updated requirements that enhance flexibility and maintain transparency and public accessibility.

Local governments across the state have faced ongoing challenges in recruiting and retaining members of the public to serve on advisory bodies subject to the Brown Act. Challenges associated with recruitment have been attributed to participation time commitments; time and location of meetings; physical limitation, conflicts with childcare, and work obligations.

The current in-person requirement to participate in local governance bodies presents a disproportionate challenge for those with physical or economic limitations, including seniors, persons with disability, single parents, caretakers, the economically marginalized, and those who live in rural areas with prohibitive driving distances; this is problematic as diversification in civic participation at all levels is essential to ensure the decisions made by advisory bodies are effective, inclusive, fair and represent the County's interests as a whole.

In Solano County, this has been a particularly important matter for several of our commissions and committees, including, and not limited to:

- The Alcohol and Drug Advisory Board
- The California Medical Facility Advisory Board
- The In-Home Supportive Services Public Authority Advisory Committee
- The Library Advisory Council
- The Measure L Library Sales Tax Measure Advisory Committee
- The Mental Health Board Advisory Committee
- The Nut Tree Airport Advisory Committee
- The Solano Commission for Women and Girls
- The Solano Childcare Planning Council

SB 239 would help address these issues by providing a narrow exemption under the Ralph M. Brown Act for non-decision-making advisory bodies that do not take final action on any legislation, regulations, contracts, licenses, permits, or other entitlements.

This bill would improve community engagement and participation for both advisory body members and members of the public alike and provide much-needed modernization for open meetings.
