Welcome and Introductions	Community Medical Center, Dixon Family Practice, La Clinica Great Beginnings, Partnership HealthPlan of California, Solano County Employment and Eligibility, Solano County Black Infant Health, Public Health Nursing, Women, Infants and Children	Action Items
CPSP State Updates	<p>WIC: Rennie shared WIC referral forms and encouraged people to continue filling them out completely, including nutrition goals and hemoglobin. Group discussed ways to help clients participate in the goal-making process and to make sure they understand and feel responsible for the goals chosen. Group discussed the possibility of using a handout that goals could be written on and the client could take home.</p> <p>Zika virus: Sherry Reed shared information on Zika virus. Solano County currently has one case, a pregnant woman. Prenatal care providers should be aware of the most recent CDC recommendations on Zika risks and testing for pregnant women. These are available on the California Department of Public Health website.</p>	
Partnership HealthPlan (PHC) Updates	<p>PHC is encouraging providers to increase their postpartum visit rates (OB visit), done between 21 and 56 days. Women in the Growing Together Program will receive a \$25 gift card for attending this visit. The Growing Together Program will also call women to remind them of postpartum appointments and to check in afterwards.</p> <p>The Perinatal Services position for Solano has not yet been filled. The expectation is that it will be filled sometime this summer.</p>	
Employment & Eligibility	<p>SB75 (Medi-Cal for undocumented children) has begun. This will cover all children under 19 years old (documented and undocumented); when undocumented children turn 19 their status will change to restricted status of adults.</p> <p>Kids who formerly had Kaiser coverage and are now covered under SB75 should be able to keep their Kaiser coverage. Children who are new enrollees should be sure to pick a provider, or one will be auto assigned for them.</p> <p>An issue was raised that clients who have state-only Medi-Cal are sometimes instructed to “call Partnership” when they have questions, which is confusing for them. Kelly says</p>	

	<p>she will remind eligibility workers not to tell clients to call Partnership if they are not Partnership clients. A reminder was made that neither Partnership nor Employment and Eligibility are in control of who is a Partnership client and who is not. That decision is made based on the aid code assigned to the person when they apply for benefits, which is based on their eligibility.</p> <p>Kelly reports that an increasing number of clients are applying for full-scope Medi-Cal by identifying themselves as a “permanent resident under color of law” on the application forms. She cautions that unless the client has specific circumstances making them eligible for this which can be adequately and properly documented, this leaves clients open to a potential fraud charge, and is not a good idea.</p>	
CPSP Site Updates/Sharing	<p>Discussion of process of getting a breastpump for breastfeeding clients who may need to return for work or school. PHC confirms that a breast pump prescription is needed, made by a clinician (PA, RN, MD). Sutter Medical Group does not currently have breast pumps from PHC because they are not a CPSP provider. La Clinica can provide breast pumps and can do this for Sutter Medical Group patients as well.</p>	
Presentation – 4PsPlus Perinatal Substance Abuse Screening	<p>Multiple sites in Solano County continue to use 4Ps Plus Substance Abuse screens. Rates of positive screens are fairly steady across time, but some clinics have a much higher rate than others. Susan encourages clients with low rates (yet similar populations to other places) to consider ways they can help clients be more comfortable disclosing substance use. Technical assistance, additional training, and skills building for staff who use the screens is available.</p> <p>In the last five to ten years, Solano has seen a significant increase in rates of opioid use, including heroin and methadone. Better coordination with the methadone clinic is recommended for managing patients using methadone. A variety of health education materials are available for substance use and pregnancy, and will be discussed more thoroughly in upcoming meetings.</p>
