Agreement for Sponsorship to the UC Berkeley Professional Program in Fundraising and Volunteer Management

This agreement (“Agreement”) sets forth our mutual understanding of the terms and conditions for the sponsorship by First 5 Solano Children and Families Commission, as a department of the County of Solano (collectively, “County”), and _____ (“Grantee”).

Grantee agrees to participate in the UC Berkeley Professional Program in Fundraising and Volunteer Management taking place fall 2017. The sponsorship is valued at \$1,950 per person and is funded primarily through a grant from Zellerbach Family Foundation.

Grantee agrees _____ (“Staff Participant”) and _____ (“Board Participant” – *optional*) will attend all four sessions of the program, complete coursework prior to and between classes, and complete a project related to their agency. Staff and Board Participants will be required to register directly with UC Berkeley Extension for program enrollment and upon completion of the course will be the recipient of a Certificate of Completion of the Professional Program in Fundraising and Volunteer Management from UC Berkeley Extension. Staff and Board Participant are material to this agreement and may not be substituted without prior written consent of First 5 Solano.

Grantee agrees to complete an outcome report six months following the conclusion of the program due no later than June 30, 2018. The report will capture progress during the program and in the six months following its conclusion. The report will include, but may not be limited to:

- Understanding of fundraising and volunteer management strategies
- Implementation of new fundraising or volunteer strategies
- Completion/implementation of a strategic fundraising plan
- Change in organizational capacity to administer new strategies/plans
- New relationships with potential funders
- New funding applied for/received

Grantee’s failure to provide to complete the course, course work, or the outcome report may make the Grantee subject to consequences up to and including being considered ineligible for future funding.

County makes this grant with the parties’ understanding that Grantee will indemnify, hold harmless and assume the defense of County, its officers, employees, agents and elective and appointive boards from all claims, losses, damages, including property damages, personal injury, death and liability of every kind, directly or indirectly, arising as a result of or in connection with Grantee’s activities in connection with this Agreement.

The parties further understand and agree that Grantee: (1) shall maintain and enforce a drug free workplace¹; and (2) shall abide by all health and safety standards set forth by the State of California and/or County pursuant to the Injury and Illness Prevention Program. The fundraising

and volunteer management materials developed in conjunction with this course may not be for religious purposes, to benefit an individual or to promote a candidate for public office.

The laws of the State of California shall govern the validity, enforceability or interpretation of this Agreement. This Agreement, including any exhibits referenced, constitutes the entire agreement between the parties and supersedes any prior written or oral agreements between them concerning the subject matter contained in this Agreement. In the event any provision of this Agreement shall be held invalid or unenforceable by any court of competent jurisdiction, such holding shall not invalidate or render unenforceable any other provision of this Agreement.
