### **NOTICE FROM THE REGISTRAR OF VOTERS ON UPCOMING MOCK ELECTION AND TEST OF NEW VOTING SYSTEM.**

Notice to all community stakeholders. The Solano County Registrar of Voters (ROV) is set to conduct a mock election at 8 locations across the county on October 16<sup>th</sup> from 10:00am to 2:00pm.

The mock election will consist of an end-to-end test of the new voting system approved by the County Board of Supervisors on June 25<sup>th</sup>, 2019. The public is invited to visit any of the 8 locations to experience the future of poll place operations with the new equipment and to visit our office in the County Administration Center to get an overview on the vote by mail ballot processing and tabulation of results.
