## WHAT IS BEING PLANNED?

Solano Irrigation District (District) proposes to expand the existing water transmission line along Pleasants Valley Road from the previously constructed Potable Water Treatment Plant in unincorporated Solano County, California. The purpose of the project is to deliver potable water to adjacent residents along Pleasants Valley Road east through adjacent properties to Bucktown Lane which is currently not available to local residents. The District is currently considering three alternatives for the transmission line. The District has prepared an Initial Study with Proposed Mitigated Negative Declaration which examines potential environmental impacts caused by the proposed project.

## WHY THIS PUBLIC NOTICE?

The District has studied the effects this project may have on the environment. The studies within the Initial Study with Proposed Mitigated Negative Declaration show it would not significantly affect the quality of the environment. This notice is to advise you that the preparation of this report has been completed and is available for you to review.

## WHAT'S AVAILABLE?

An Initial Study with Proposed Mitigated Negative Declaration has been prepared and is available for public review beginning August 13th, 2020 through September 12th, 2020. 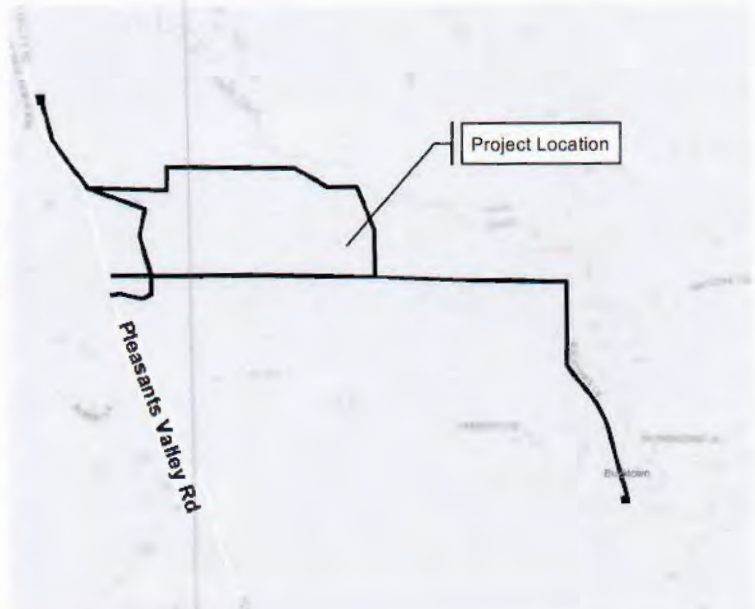
