SUBJECT: NOTICE OF INTENT TO ADOPT NEGATIVE DECLARATION PURSUANT TO SECTION 21092 AND 21092.3 OF THE PUBLIC RESOURCES CODE AND CEQA GUIDELINES SECTION 15072

Project Title: Proposed Amendments to Air District Regulation 2, Rule 1 (Permits – General Requirements) and Proposed Amendments to Regulation 2, Rule 5 (Permits – New Source Review of Toxic Air Contaminants).

Project Location: The rule and proposed amendments apply within the Bay Area Air Quality Management District (“Air District”), which includes all of Alameda, Contra Costa, Marin, Napa, San Francisco, San Mateo, and Santa Clara counties, and the southern portions of Solano and Sonoma counties.

Project Description: The Air District has regulatory authority over stationary sources of air pollution in the San Francisco Bay Area. The proposed amendments to Regulation 2, Rule 1 (Rule 2-1) and Regulation 2, Rule 5 (Rule 2-5) address how the Air District issues permits for sources of air pollution, with particular emphasis on increasing health protection in communities overburdened by pollution and health vulnerabilities. The Air District has prepared a Staff Report that provides a summary of the rationale for updating these rules. Background information and analysis is also available in the Staff Report. The proposed amendments and Staff Report are intended to provide the public with information in advance of a Public Hearing.

Public Hearing: On Wednesday, December 15, 2021, at 9:30 a.m., the Board of Directors of the Bay Area Air Quality Management District will conduct a public hearing to consider adoption of proposed amendments to Regulation 2, Rule 1 (Permits - General Requirements) and Regulation 2, Rule 5 (Permits – New Source Review of Toxic Air Contaminants) and the adoption of a Negative Declaration pursuant to the California Environmental Quality Act (CEQA). The hearing will be held via webcast at www.baaqmd.gov or as soon thereafter as the matter may be heard.
