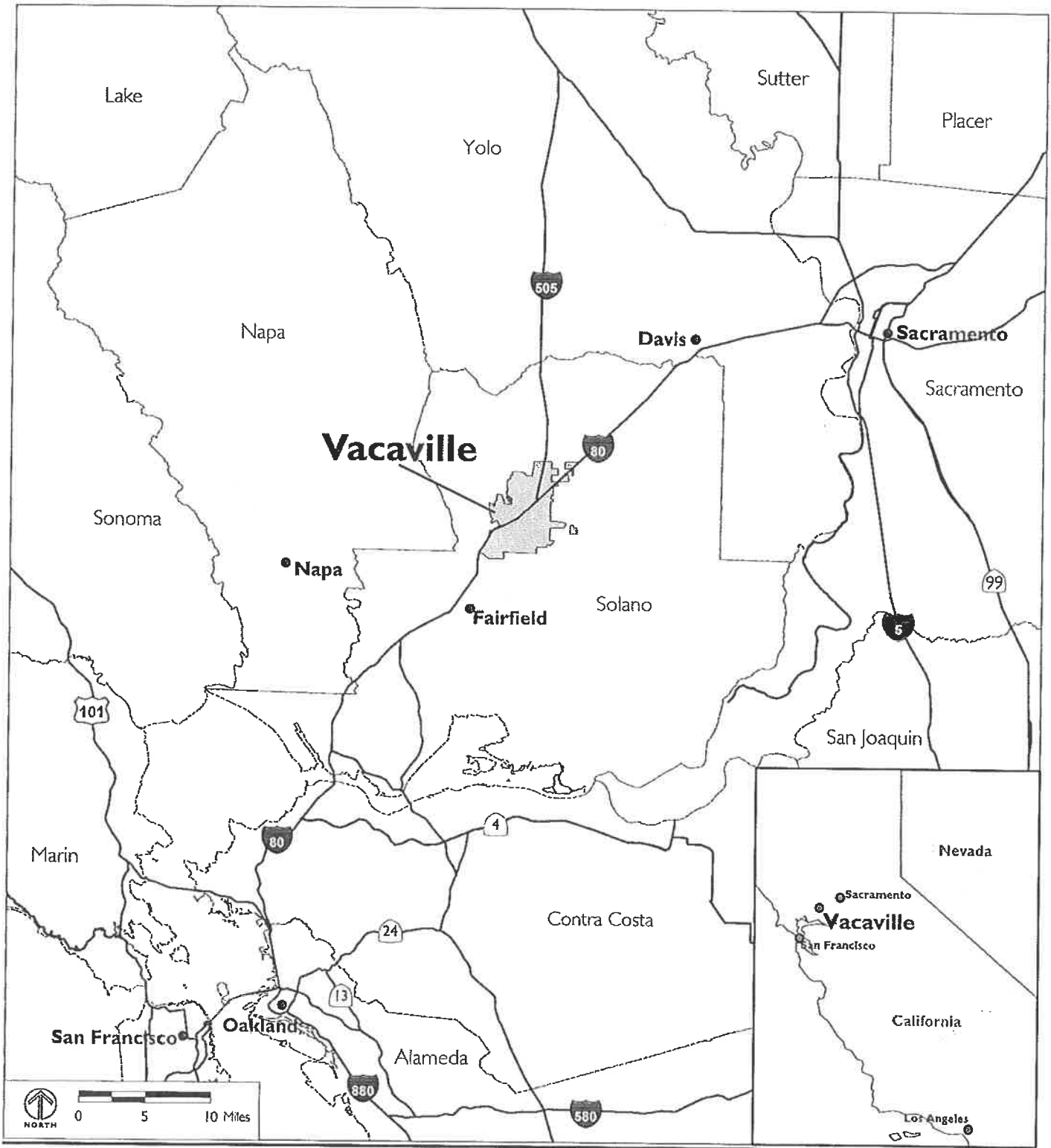


FIGURE 1
