Notice of Intent to Adopt a Mitigated Negative Declaration and Notice of Availability of an Initial Study with Proposed Mitigated Negative Declaration/Environmental Assessment (IS-MND/EA) for the Real McCoy Fenders and Ramps Replacement Project

WHAT'S THIS PROJECT?

The purpose of the proposed project is to restore the structural integrity of the fender system and upgrade the boat ramps and ferry deck to improve ferry boat accessibility across Cache Slough on State Route 84. The Project would replace the Real McCoy Ferry's deteriorating timber fender system with a new steel pile fender system; replace the boat ramps with new concrete approach slab ramps that would accommodate larger vehicles, including commercial and emergency vehicles, and extend the ferry boat deck to improve vehicle access on and off the ferry.

WHY THIS AD?

Caltrans has prepared the Draft IS-MND/EA to explain why the proposed project would have less than significant impacts on the environment with mitigations. This public notice is to inform you that the IS-MND/EA has been prepared and will be available for review during a 30-day public comment period between **April 29, 2022**, and **May 28, 2022**, and that a virtual public meeting will be held for the project on **May 17, 2022**, from 5:30 pm to 7:00 pm.

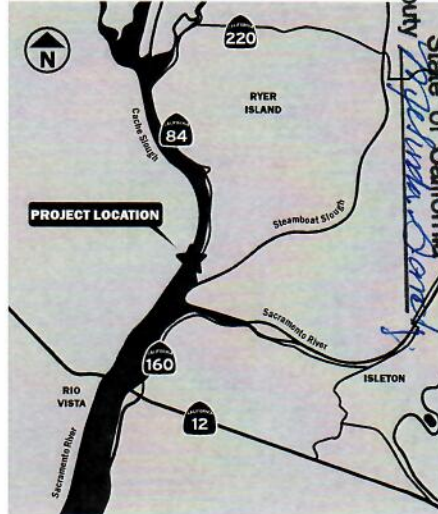
