EMPLOYMENT AND ELIGIBILITY: CELEBRATING SUCCESS IN EXCEEDING CALFRESH MANDATES

The E&E Division has surpassed timeliness mandates for the CalFresh program, processing over 90% of both Expedited Services (ES) and regular applications. Since June 2024, the average timeliness rate for ES has been 97%, while regular applications have maintained 96% since May 2024.

Despite challenges such as a 16% increase in applications, staffing shortages, and the transition to a new eligibility system, E&E faced a brief dip in meeting the 90% timeliness mandate. To address this, E&E implemented strategies such as offering overtime, collaborating with non-intake bureaus, and redesigning intake processes. A block appointment scheduling system, piloted in Vallejo and expanded to Fairfield & Vacaville in 2025, improved availability and flexibility. The clerical team focused on timely application registration, improving efficiency.

These efforts have led to recognition by the California Department of Social Services (CDSS), with E&E invited to present at the CalFresh Roundtable to share their success story! Great work Team!

CHILD WELFARE SERVICES: BECOMING A KIN-FIRST CULTURE

NATIONAL PUBLIC HEALTH WEEK 2025

Foster care is a temporary, court-monitored service designed to ensure the safety and well-being of children, with funding and regulation provided through collaboration between federal and state governments. As of February 2024, there are 324 children in foster care in Solano County.

Kinship care, or placement with relatives, is the preferred foster care setting, as it helps with greater stability, fewer placement disruptions, stronger chances of permanency, and reduced trauma by maintaining children's connections to their family, culture, and community. Caregivers undergo training and licensing, known in California as Resource Family Approval (RFA), to prepare them for supporting children who have experienced trauma.

Solano County prioritizes a **"kin-first"** approach, although non-relative caregivers are used when kinship care is not possible. Our Child Welfare Services' Resource Family Approval (RFA) program certifies both relative and non-relative caregivers, actively identifying and engaging kin through thorough family inquiries and outreach.

As of March 2025, there are 194 approved Resource Homes. From October 2023 to September 2024, 30.8% of first foster care placements were with relatives, according to the California Child Welfare Indicators Project.

COMPLIANCE CORNER

As a county employee, it is crucial to protect sensitive information like Protected Health Information (PHI) and Personally Identifiable Information (PII) due to legal and ethical obligations. Mishandling this data can result in identity theft, legal issues, and reputational harm, often caused by oversights or unawareness.

To reduce risks, employees should:

- Securely store documents
- Limit access to authorized personnel
- Never leave sensitive data unattended on devices

Additionally, emails should be double-checked for accuracy, and any breaches must be reported immediately, with detailed reports aiding response efforts. Regular training and adherence to procedures are vital for preventing breaches.

We are excited to announce some accomplishments in ODAS!

- 1. Completed our first In-Home Supportive Services (IHSS) Training Cohort earlier this year. Our Social Services Manager, **Mike Watson**, Social Services Supervisor, **Jacque Russell Bibb**, and Social Services Program Coordinator, **Vang Xiong**, led this effort! Our Social Services Supervisors supported this training with monitoring and home visit support. Over 4 months, seven successful Social Workers learned the complexities of IHSS and are thriving in assessing clients for services!
- 2. Our IHSS Quality Assurance team, **Michelle Ilaoa**, and **Jacque Russell-Bibb**, completed an IHSS annual monitoring review with minimal findings for the California Department of Social Services. This is quite a feat as we serve over 6,800 IHSS recipients, and our QA team must review over 300 cases for the state to choose a portion of these to review!
- 3.Our Napa Solano Area Agency on Aging Executive Director **Elaine Clark** and support from Clerical Operations Supervisor **Jaquetta Jefferson** received a perfect score, the highest rating ever on a California Department of Aging program monitoring review of hundreds of submitted program documents. Our eight monitoring meetings were so short since the auditors repeatedly commented "Amazing! Great effort! Can you talk with other counties?!!"
